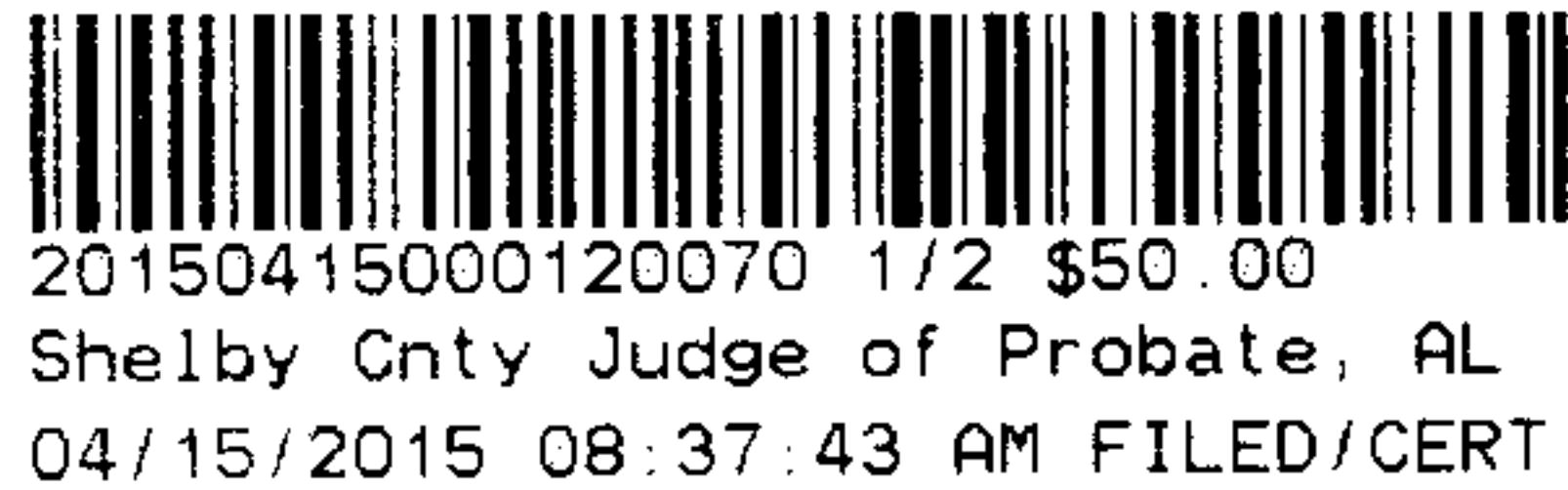

Lots 1 & 2, according to Edmondson Family Subdivision, as recorded in Map Book 40, Page 100, Probate Office of Shelby County, Alabama.


SUBJECT TO:

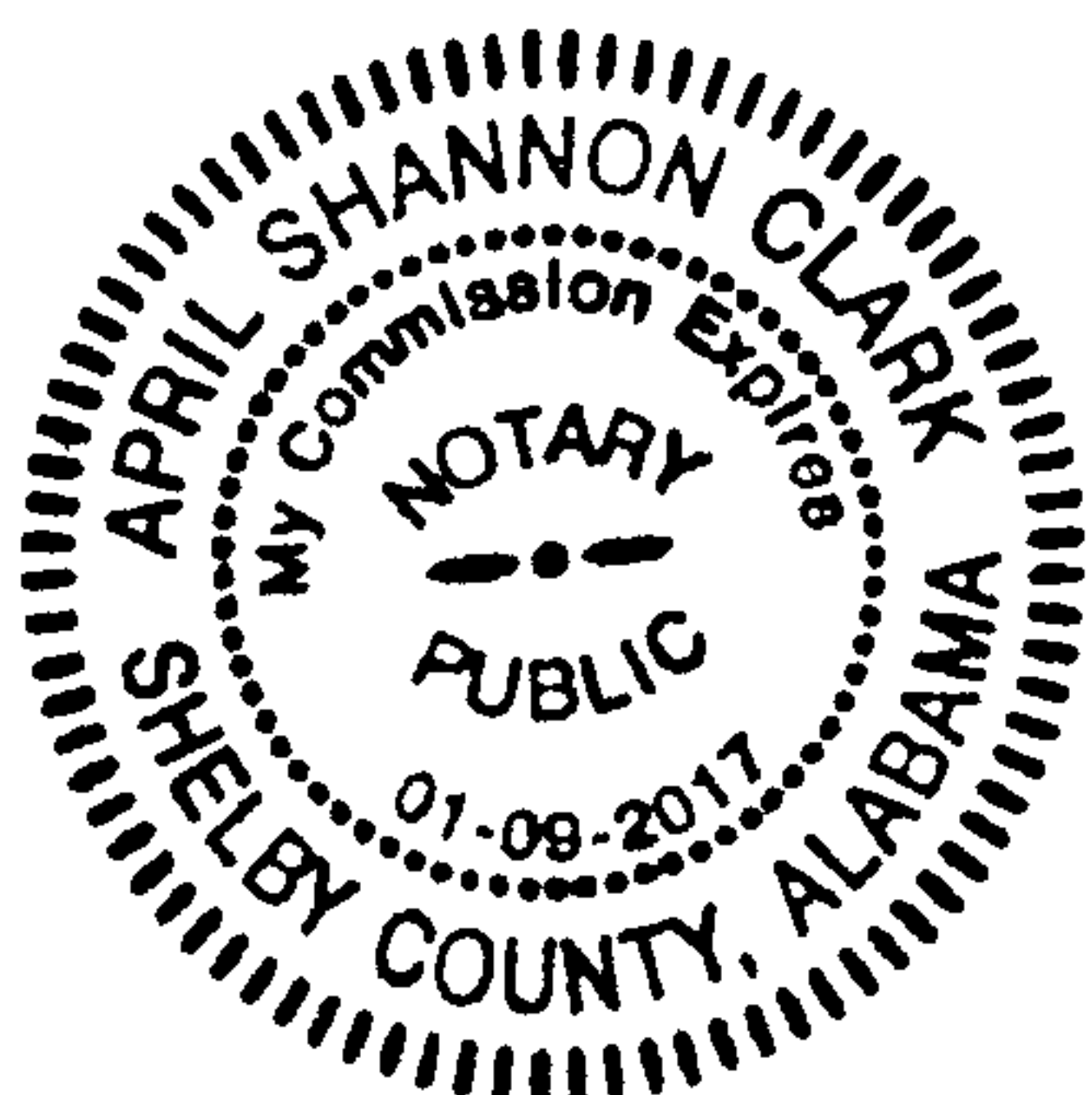
