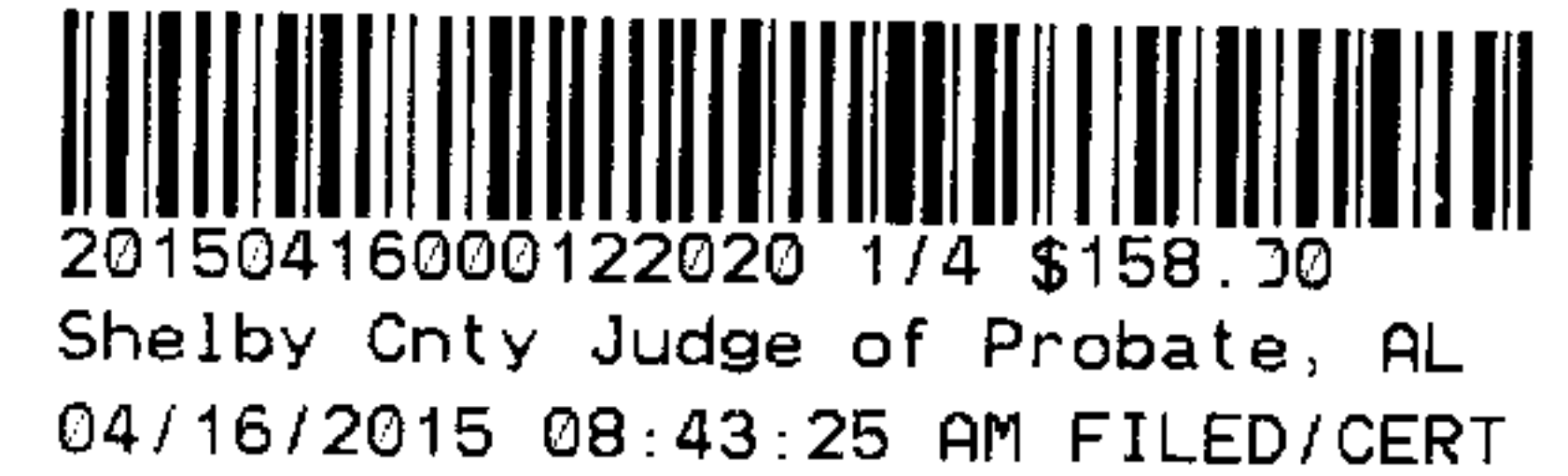


**ARTICLES OF ORGANIZATION OF  
SPORTIME AUTOSALES, LLC**



Pursuant to the Provisions of Section 10-2-1, et seq., of Code of Alabama (1975), the undersigned hereby adopt the following Limited Liability Company Articles of Organization.

**ARTICLE I**

The name of the limited liability company is Sportime Autosales, LLC (the "Company").

**ARTICLE II**

**Duration**

The Company shall have a duration from the date of organization until perpetual unless it is dissolved and its affairs wound up prior to that date in accordance with the Alabama Limited Liability Company Act (the "Act").

**ARTICLE III**

**Purposes**

The purposes for which the Company is formed are:

- A) To engage in the business of selling automobiles for personal and commercial use and associated activities relative to that in accordance with the laws of the State of Alabama.
- B) To engage in any other lawful act or activity for which limited liabilities companies may be organized pursuant to the Act.

## ARTICLE IV

### **Registered Office; Registered Agent**

The location and street address of the initial registered office of the Company shall be located at 3925 Hwy.25, Montevallo, Alabama 35115. The registered agent shall be Roberto Antonio Escobar.

The cessation of membership of one or more members will result in the dissolution of the Company unless the membership takes action to amend this article.
