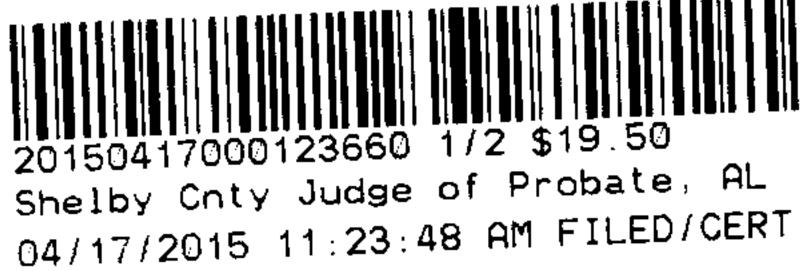
IN THE PROBATE COURT OF SHELBY COUNTY, ALABAMA CASE NO. PR-2015-000198
