#### SUBORDINATION AGREEMENT

LATIMER and encumbering that certain real property located at 1056 GRANDE VIEW PASS, ALABASTER, AL 35007 (address) which is legally described on Exhibit "A" attached hereto and incorporated herein (the "Property"), which Security Document was recorded on 05/31/2007 in Official Records Book N/A, Page N/A, as Instrument No. 20070531000254200, of the Official Records of SHELBY County, Alabama, as the same may have been or is to be modified prior hereto or contemporaneously herewith.


WHEREAS, CitiBank, N.A.
