KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 4th day of June, 2010, Washeka N. Reese, an unmarried individual, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for First Community Mortgage Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20100618000195120, said mortgage having subsequently been transferred and assigned to U.S. Bank Trust, N.A., as Trustee for LSF9 Master Participation Trust, by instrument recorded in Instrument Number 20150213000046970, in the aforesaid Probate Office ("Transferee"); and

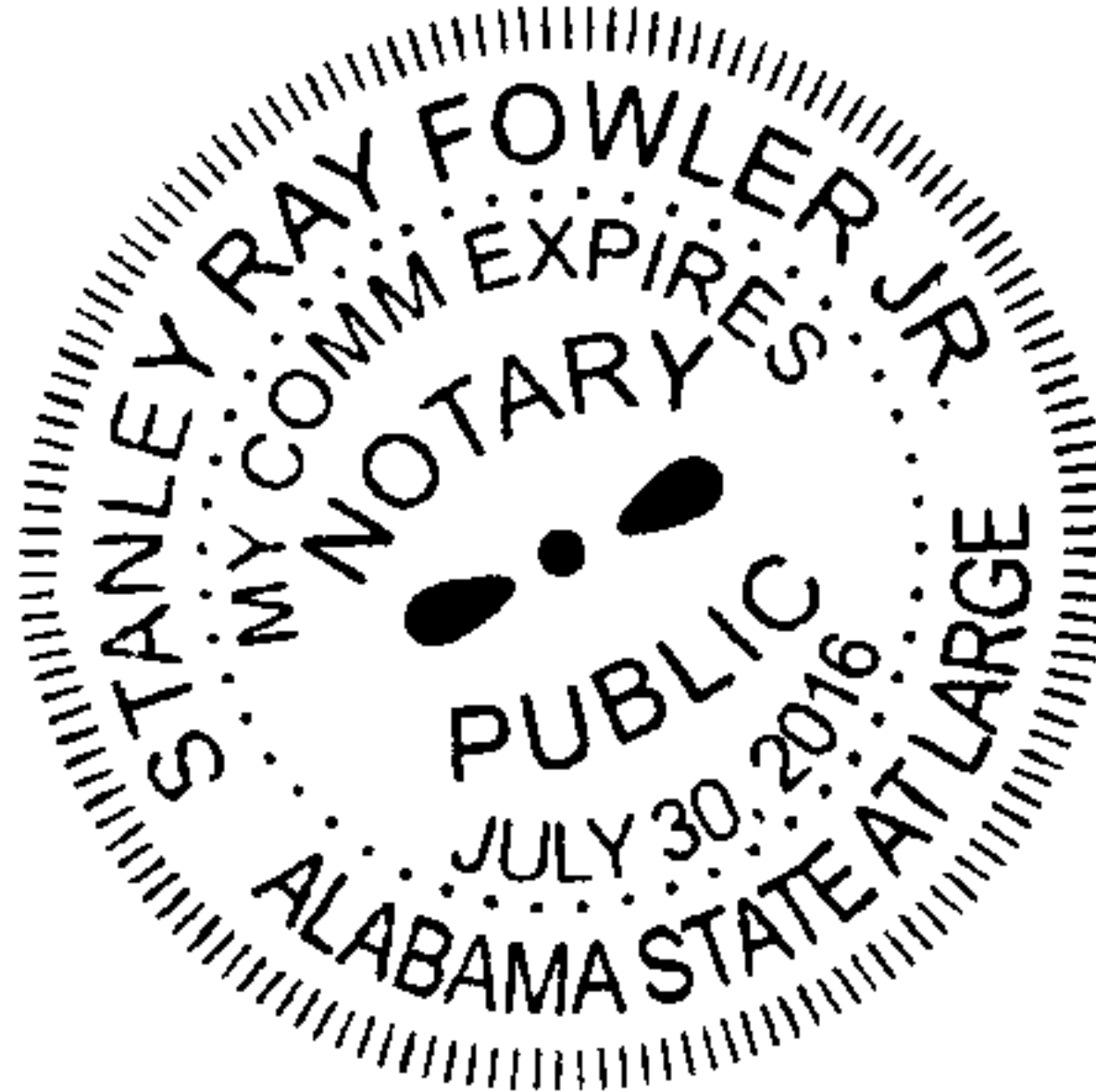
