KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 3rd day of July, 2008, Aaron P. Foster and Regina P. Foster, as husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Renasant Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20080710000278440; having been modified by Loan Modification Agreement recorded in Instrument Number 20140818000258240, said mortgage having subsequently been transferred and assigned to Lakeview Loan Servicing, LLC, by instrument recorded in Instrument Number 20140211000039140, in the aforesaid Probate Office ("Transferee"); and

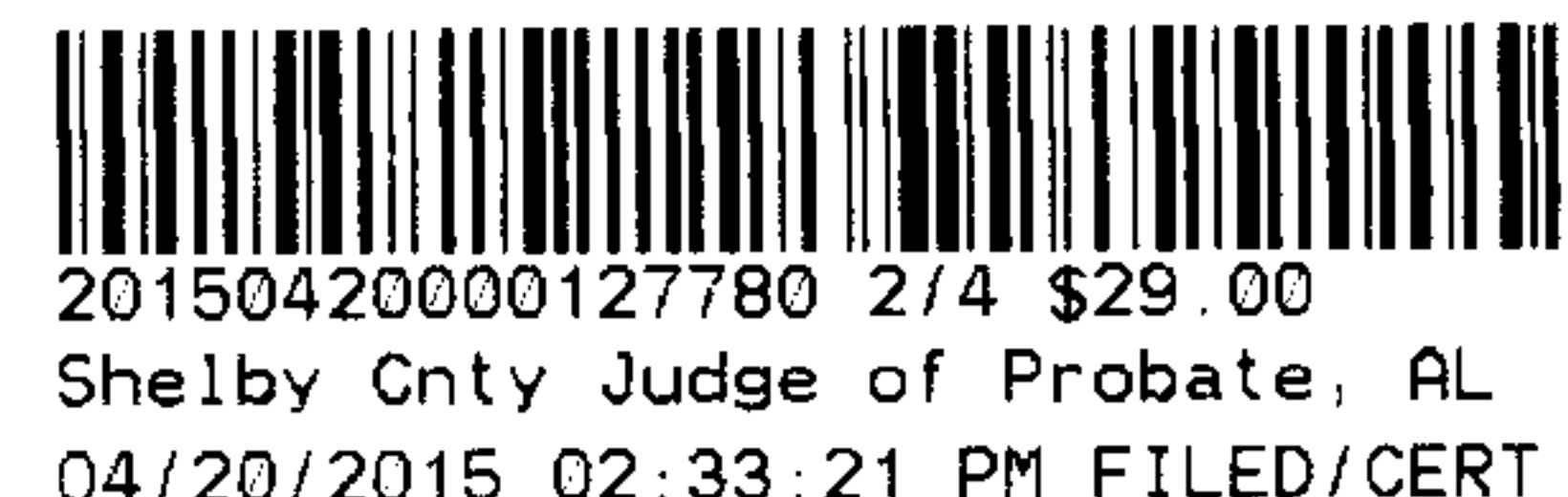
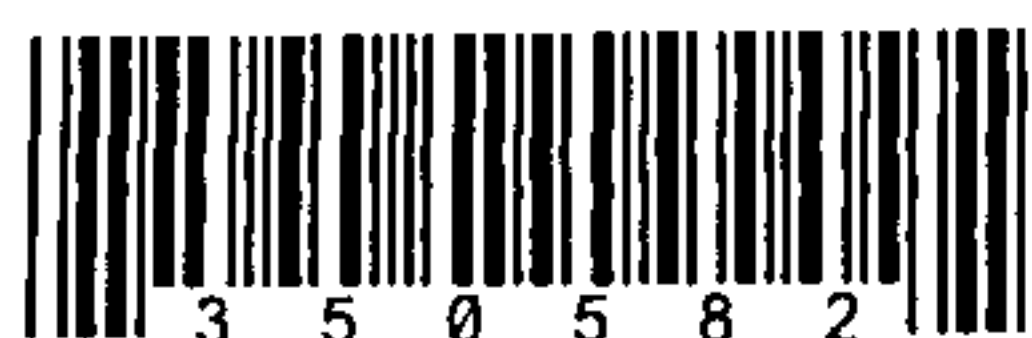

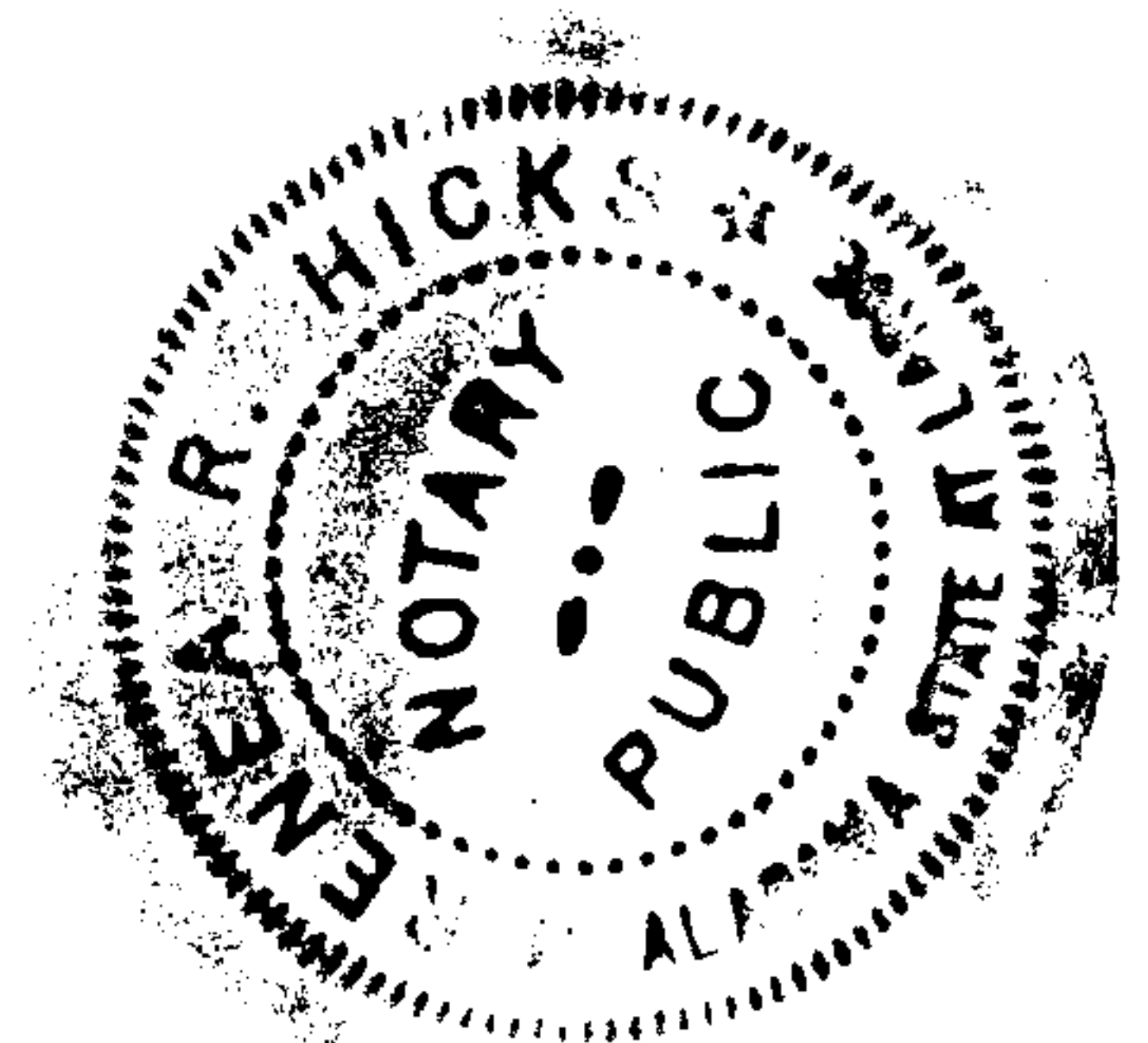
