That in consideration of FOUR HUNDRED TWENTY FIVE THOUSAND and 00/100 Dollars (\$425,000.00) to the undersigned GRANTOR in hand paid by the GRANTEE herein, the receipt of which is hereby acknowledged, Vestavia Village, L.L.C., an Alabama limited liability company (herein referred to as GRANTOR) does hereby grant, bargain, sell and convey unto Kittrell Properties, L.L.C., an Alabama limited liability company (herein referred to as GRANTEE), the following described real estate situated in Shelby County, Alabama to-wit:

Lot 1, according to the Map of Kent Farms Commercial Complex, located in the S ½ of Section 14 & the N ½ of Section 11, Township 21 South, Range 3 West, as recorded in Map Book 40, Page 56, in the Office of the judge of Probate of Shelby County, Alabama.

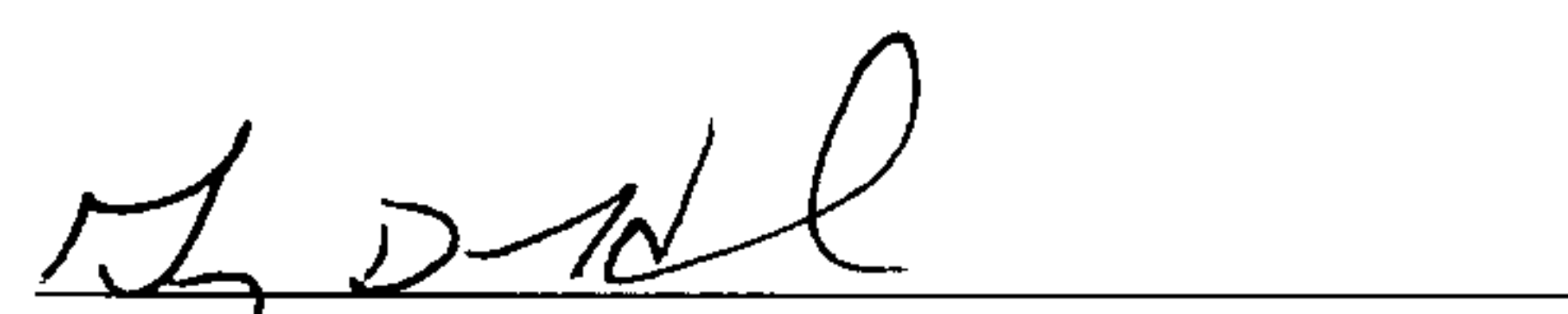
