



Be it known that \$97,500.00 of the purchase price recited above was paid from mortgage loan closed simultaneously herewith.

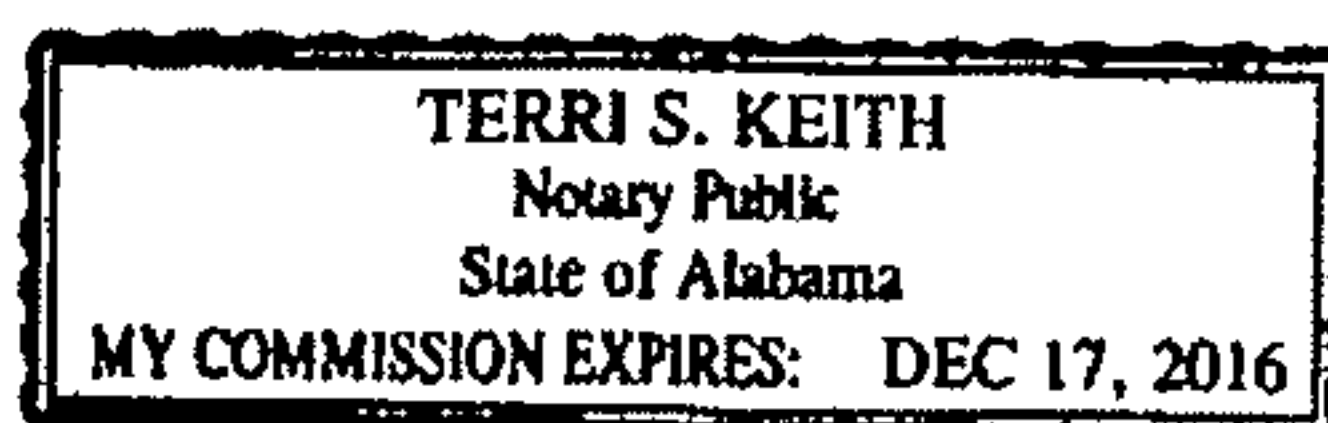
