The limited liability company shall have two managers who shall serve until the first annual meeting or until their successors are elected and qualified. The primary manager shall be:

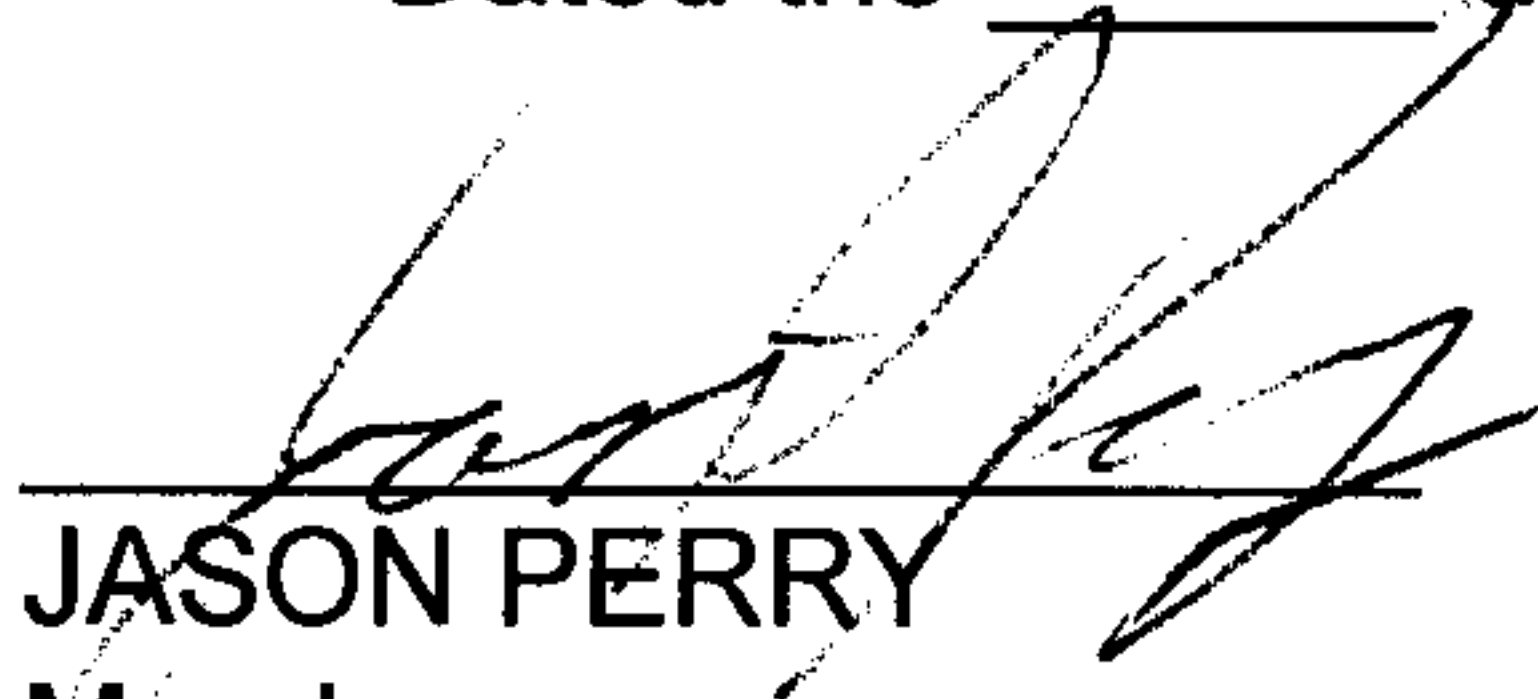

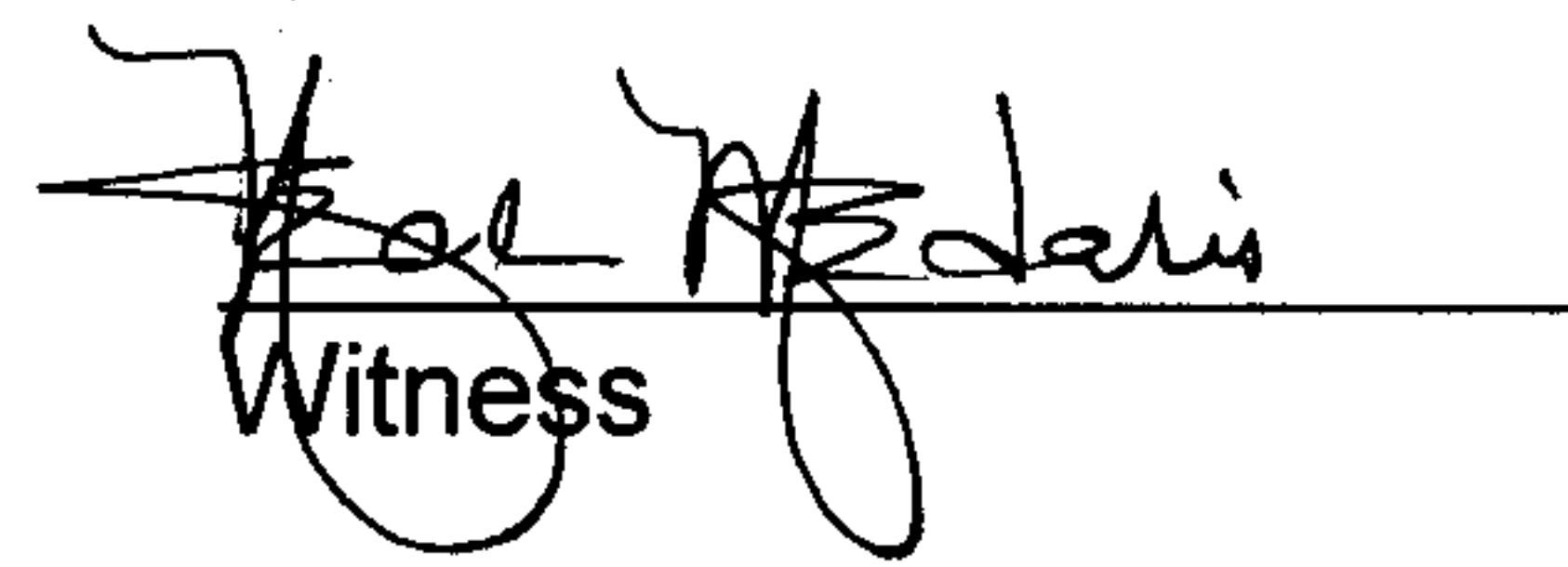
ARTICLE ELEVEN

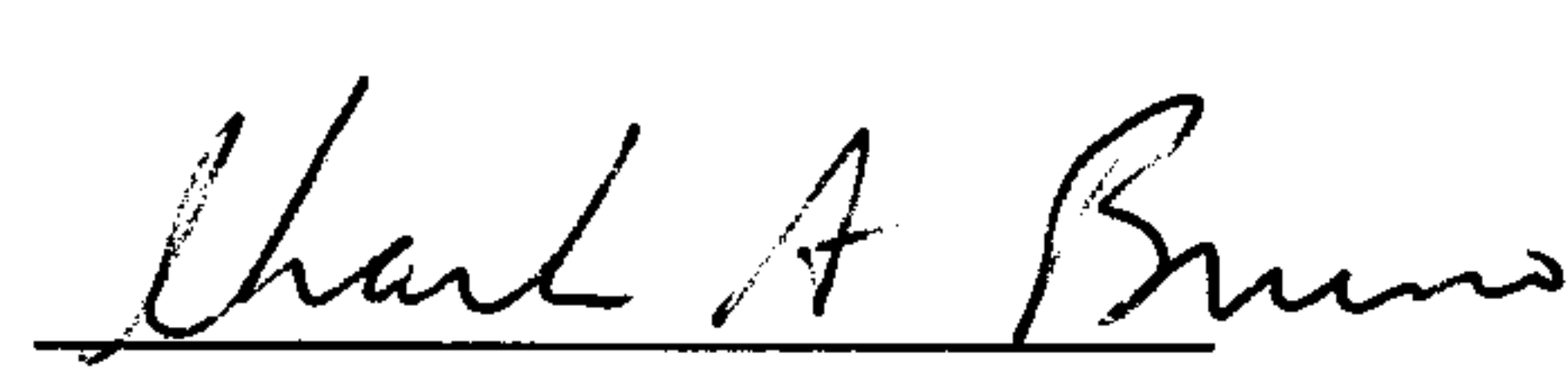

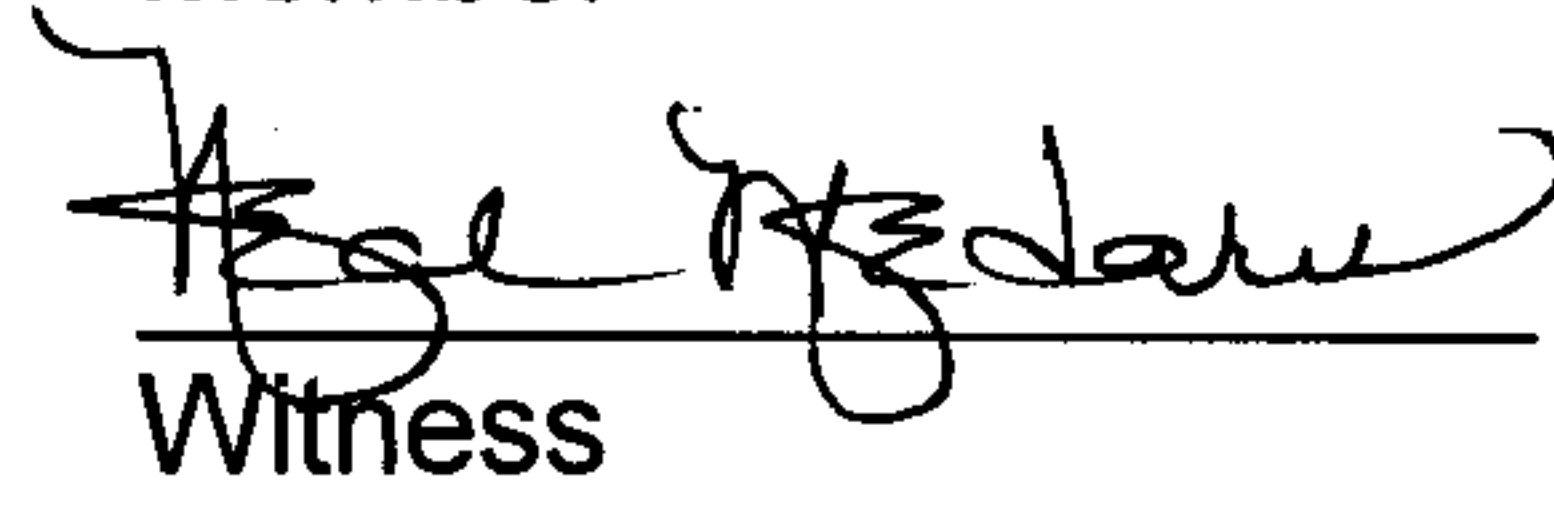
