KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 27th day of April, 2004, Jill T. Thomas and husband Patrick D. Thomas a/k/a Patrick Thomas, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Castle Mortgage Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20040506000240050, modified in Instrument Number 20110509000138870, said mortgage having subsequently been transferred and assigned to Cenlar FSB, by instrument recorded in Instrument Number 20141217000395820, in the aforesaid Probate Office ("Transferee"); and

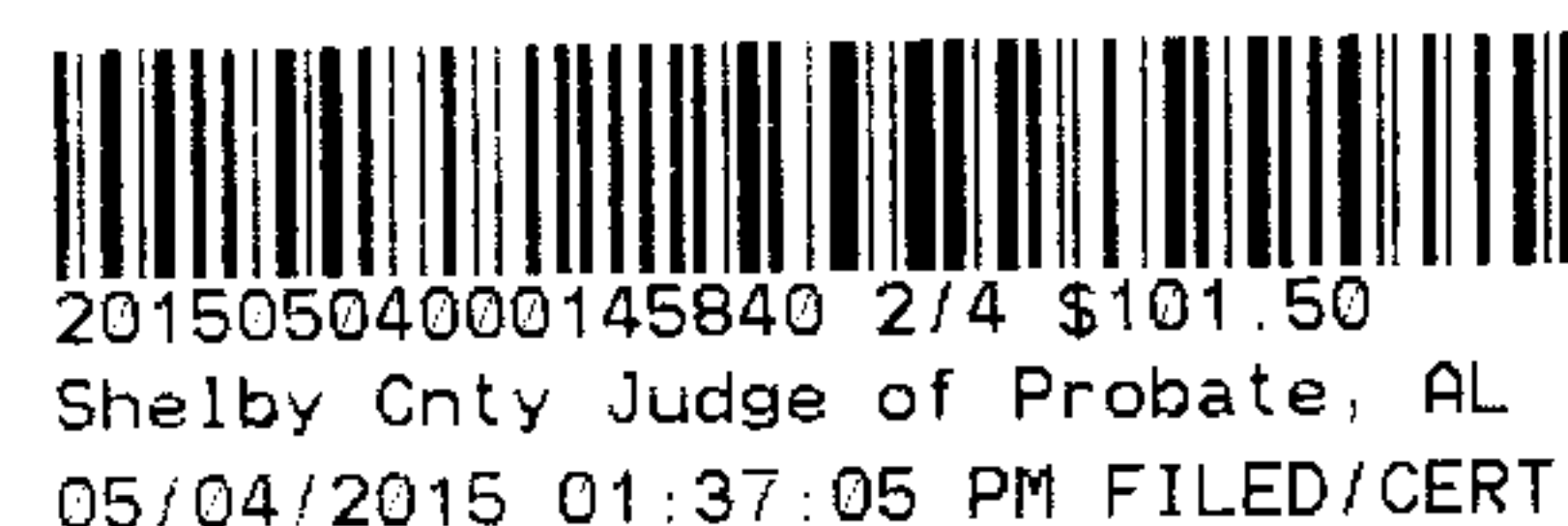

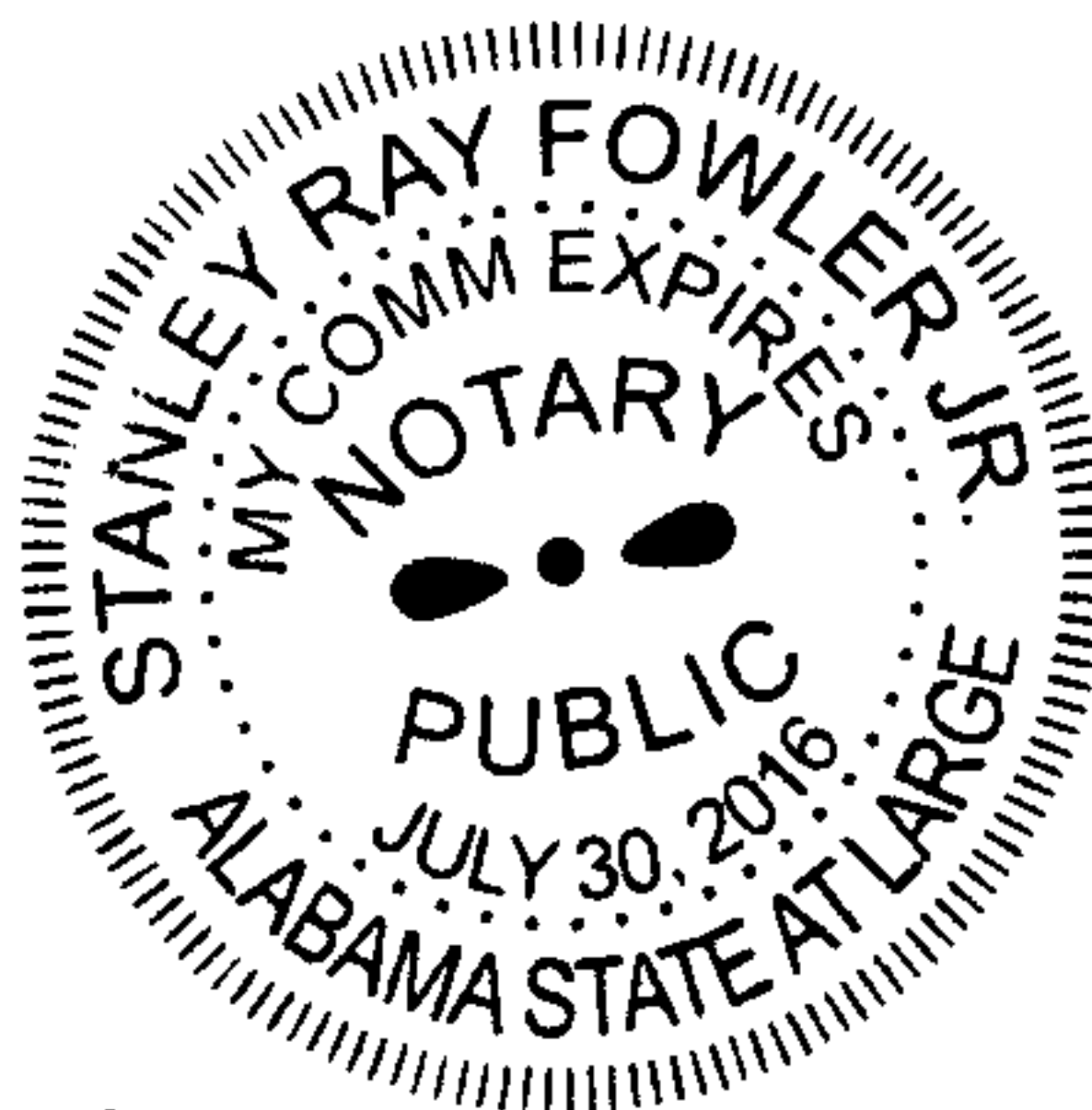

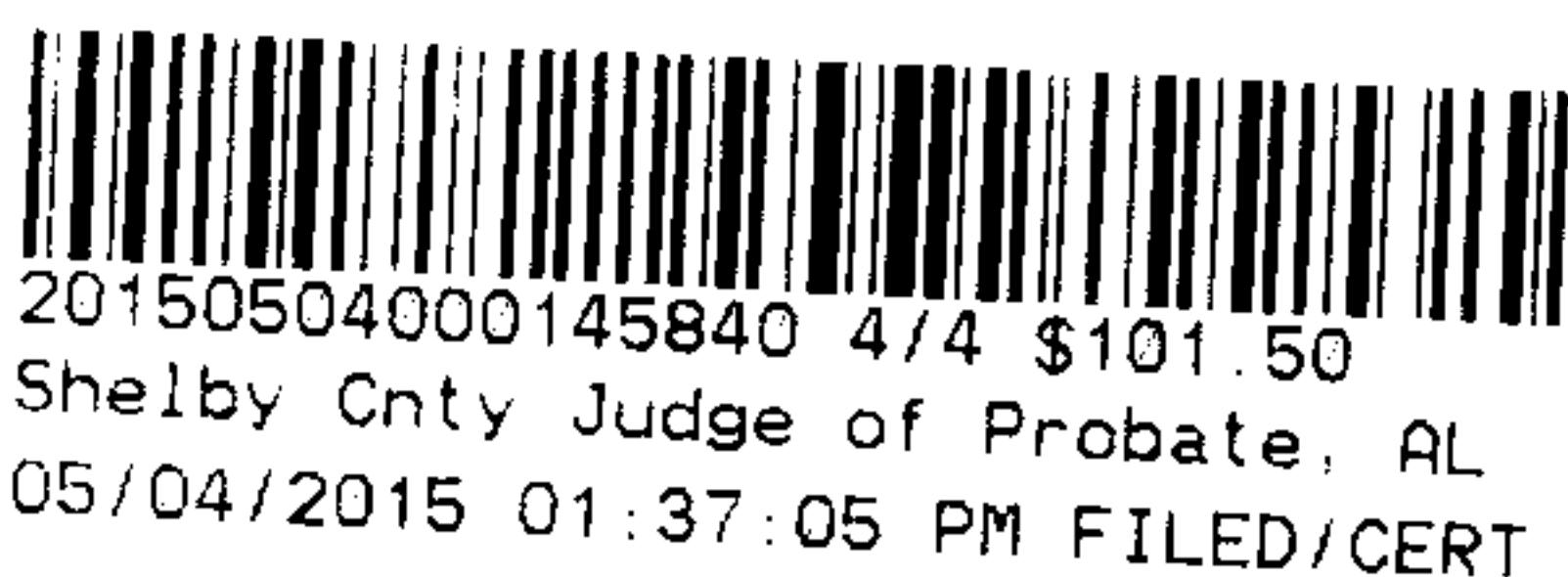
