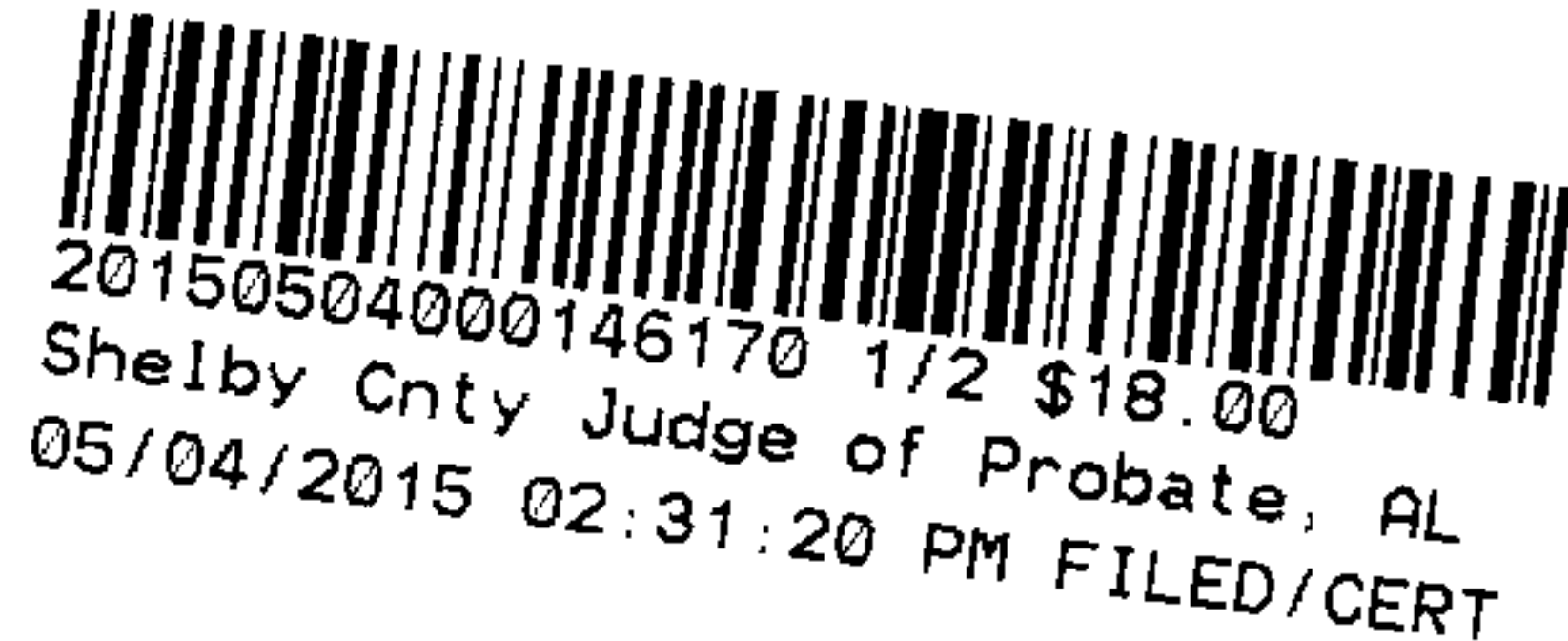


WARRANTY DEED
