**AFFIDAVIT REGARDING CERTIFICATION OF TRUST

1. The Guy W. Milford and Sandra Braman Living Trust dated November 21, 2007, is a valid, existing trust, having been created by Guy W. Milford and Sandra Braman Trust Agreement dated November 21, 2007.
2.
 - A. The original settlors of the trust are Guy W. Milford and Sandra Braman.
 - B. The following persons contributed money, funds, real property or personal property to the trust: Guy W. Milford and Sandra Braman.
 - C. Guy W. Milford and Sandra Braman are alive and well.
 - D. The name of the currently acting trustees are Guy W. Milford and Sandra Braman.

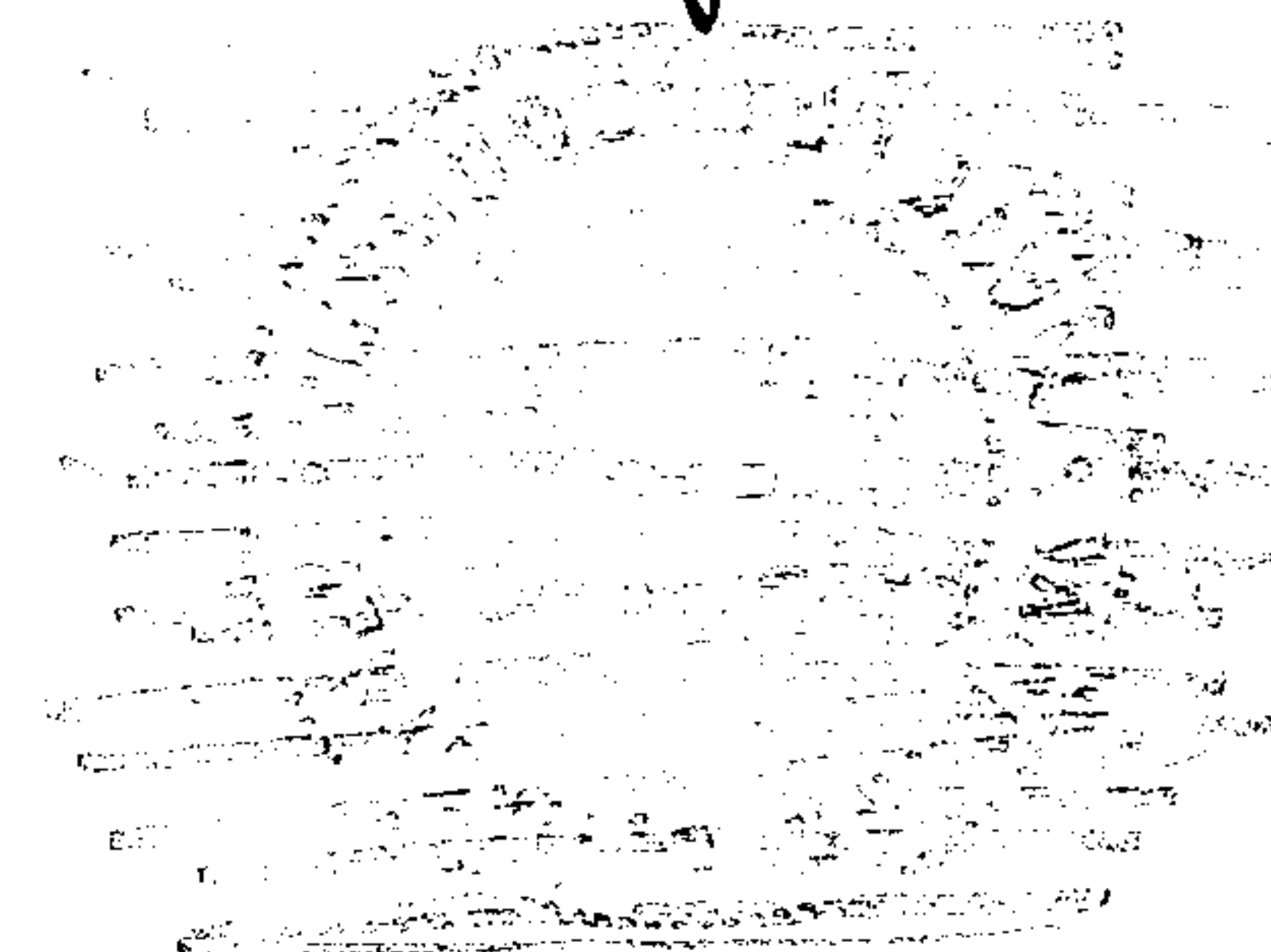
