

**ARTICLES OF ORGANIZATION
OF
CAMP SCOTTY, L.L.C.
A LIMITED LIABILITY COMPANY
ORGANIZED UNDER THE LAWS OF THE STATE OF ALABAMA**

The undersigned, acting as the organizers of a limited liability company under the Alabama Limited Liability Company Act (the "Act"), hereby adopt the following Articles of Organization for Camp Scotty, L.L.C. (hereinafter called the "Company")

1. The name of the Company is Camp Scotty, Limited Liability Company (LLC).
2. The Company shall continue in existence until it is dissolved in accordance with the provisions of the operating agreement, or, if there is no operating agreement or no provision in the operating agreement governing the duration of the Company, then in accordance with the Alabama Limited Liability Company Act, or other applicable laws.
3. The Company is organized for the purpose of providing facilities for the customers' abilities to board, obtain daytime care, perform do-it-yourself dog washing and obtain grooming of customers' pets by Company.
4. The mailing address of the initial registered office is 2785 Pelham Parkway, Pelham, Alabama 35124 and the name of the initial registered agent of the Company at such address is Steven Earl Scott, Sr.
5. The names and addressed of the initial members of the Company are:

6. The initial members of the Company may admit additional members at such times and upon such terms and conditions as may be agreed by the Company and the additional members.
7. The legal existence and business of the Company may be continued by the written consent of all the remaining members within thirty (30) days after an event of disassociation of a member.
8. The Company shall be managed by one or more managers. The name and mailing address of the initial managers, who shall serve as managers until the first annual meeting of members of the Company or until their successor or successors are duly elected, is: Steven Earl Scott, Sr.

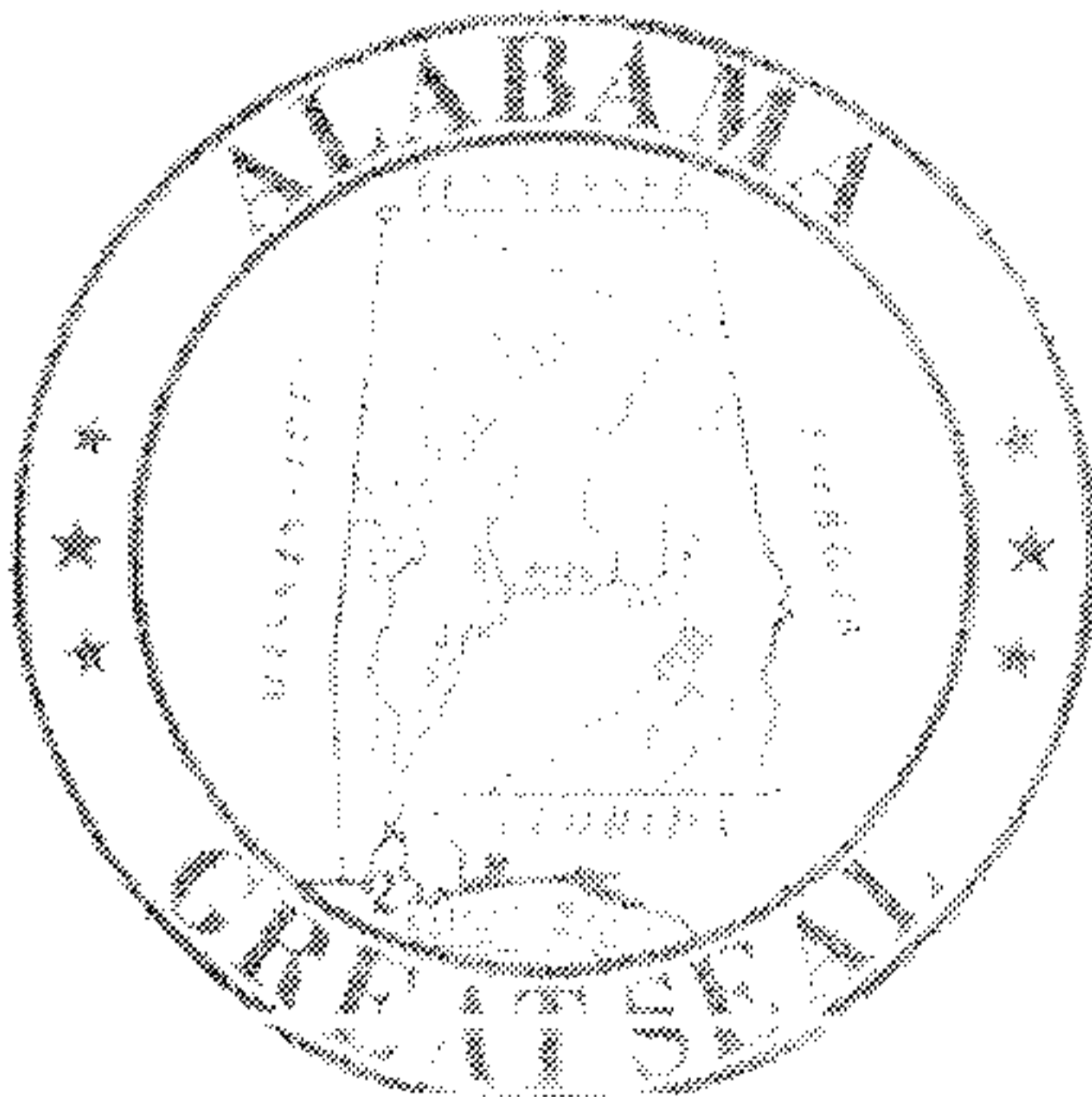
