KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of Two Hundred Sixty-Four Thousand Five Hundred And No/100 Dollars (\$264,500.00) paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Sherry Lanier Pugh, an unmarried woman, and Jean G. Lanier, an unmarried woman (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Andy E. Brown and Mary Beth Brown (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.


