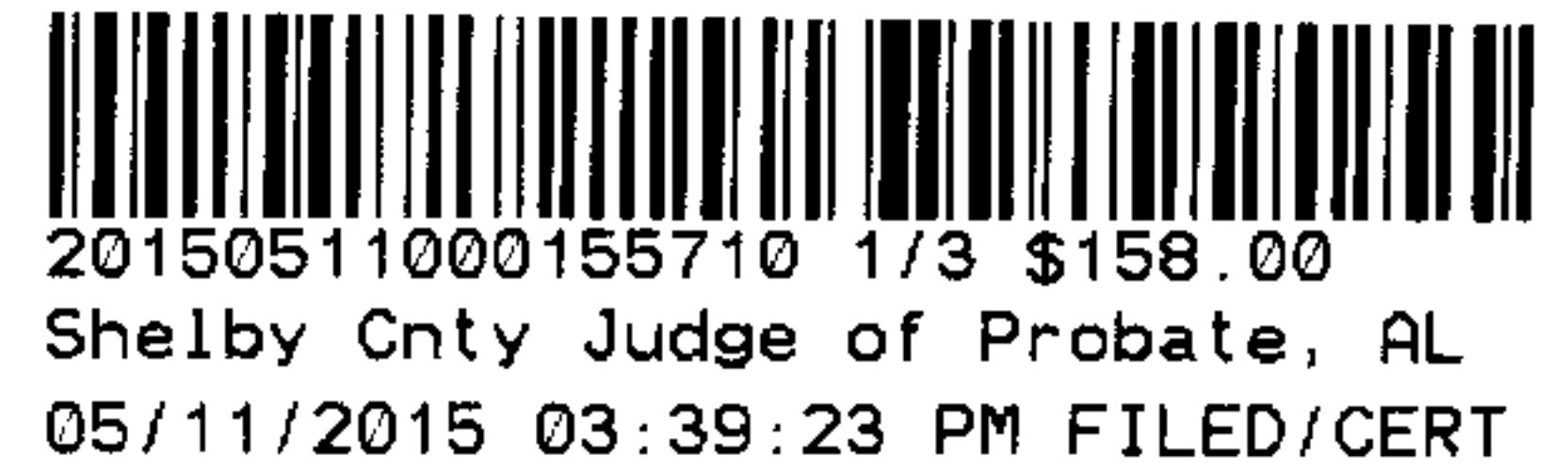


CERTIFICATE OF FORMATION

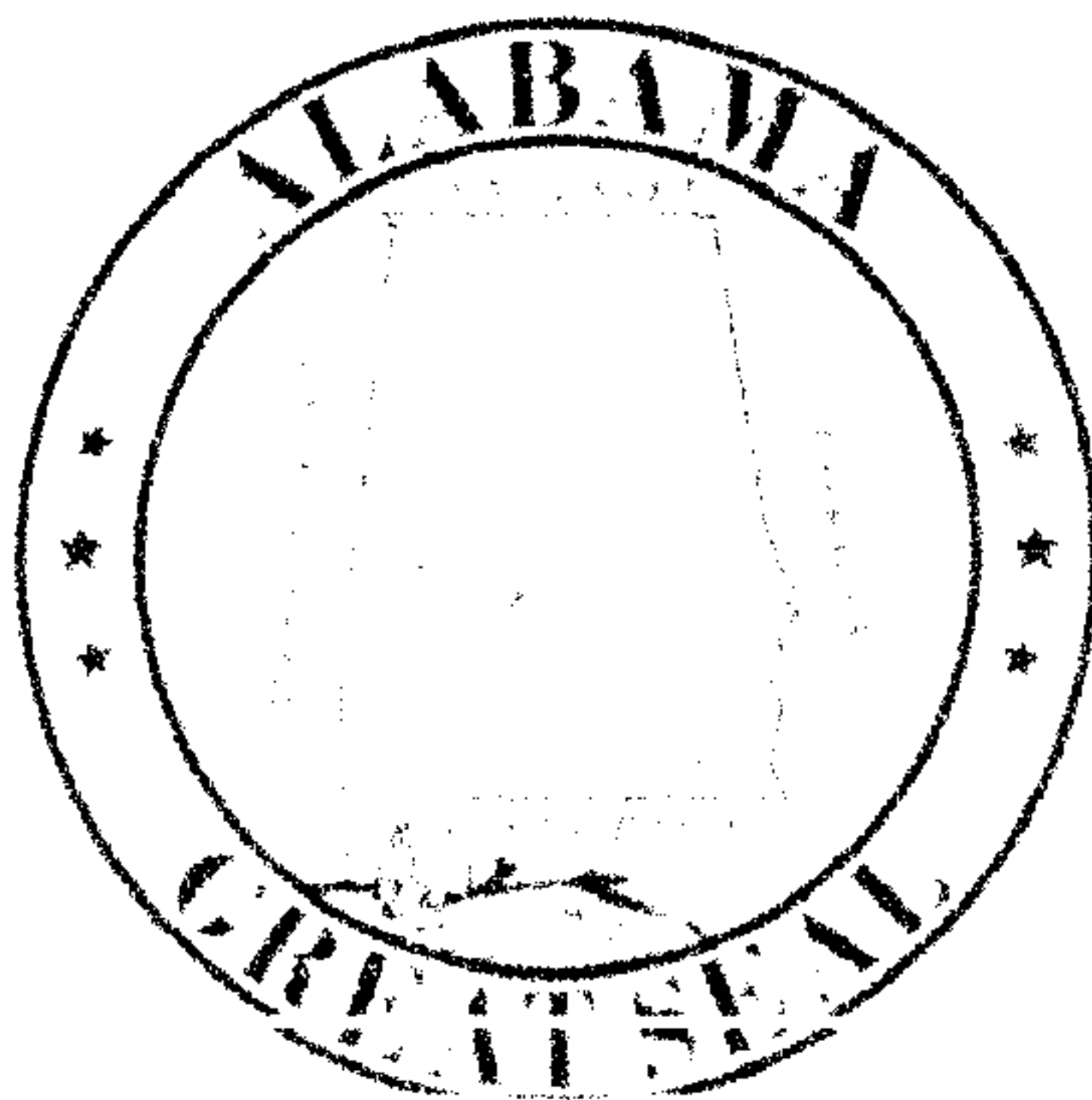
