

**CERTIFICATE OF FORMATION
OF
GRAVLEE FARM, LLC**

Pursuant to the Alabama Limited Liability Company Act (the "Act"), the undersigned hereby adopts the following Limited Liability Company Certificate of Formation:

ARTICLE I

NAME

GRAVLEE FARM, LLC

ARTICLE II

DURATION

The term shall be perpetual, unless the Company shall be sooner dissolved and its affairs wound up in accordance with the Alabama Limited Liability Company Act or the Operating Agreement.

ARTICLE III

PURPOSES

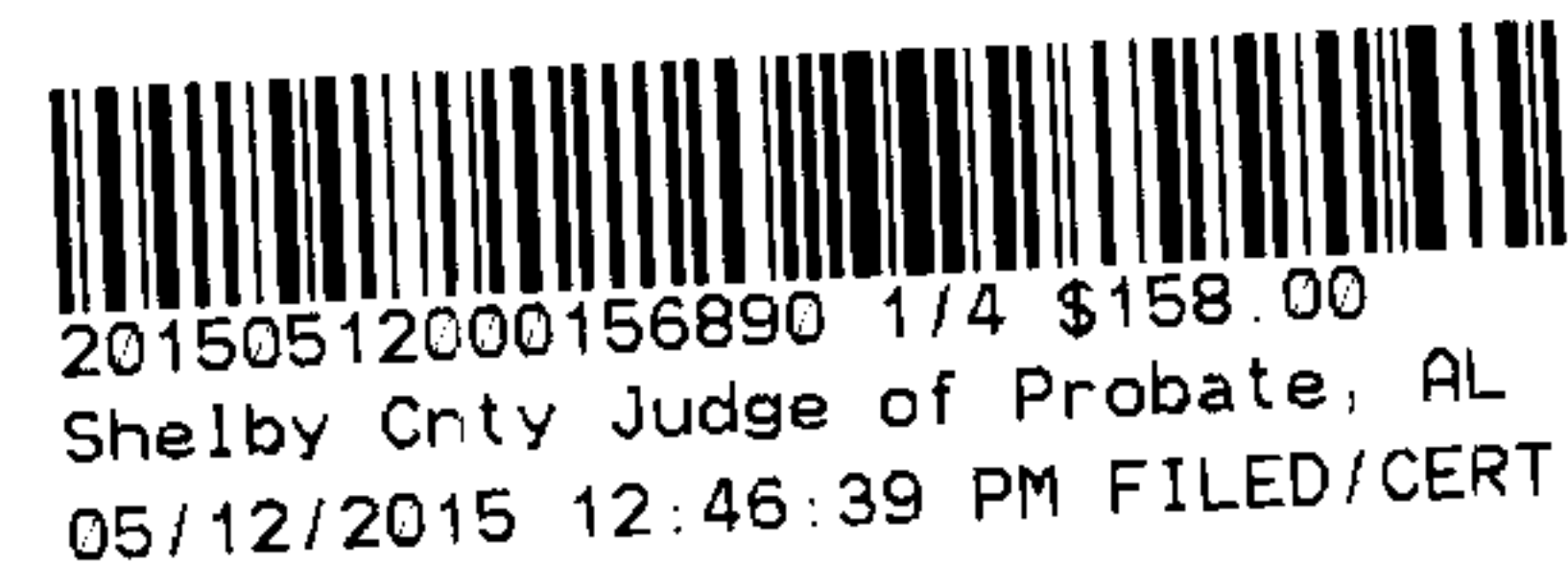
The Limited Liability Company has been organized for the following purposes:

To engage in the ownership, operation and management of a farm located in Talladega County, Alabama, and to engage in such other lawful activities permitted to limited liability companies by the Alabama Act.

ARTICLE IV

REGISTERED AGENT/OFFICE

The location and street address of the initial registered office shall be at 2200 Resource Drive, Birmingham, Alabama 35242, and its registered agent at such address shall be Donovan H. Gravlee.



ARTICLE V
INITIAL MEMBERS

The Company shall have two classes of Members, namely Class A and Class B Members. Class A Members shall have the full, exclusive, and complete discretion, power and authority, subject in all cases to the provisions of the Operating Agreement and the requirements of applicable law, to vote on all matters which require the approval of the Members. Except as set forth in the Operating Agreement or as required by applicable law, no Class B Member shall have the right to vote on any matter concerning the affairs of the Company. Class A and B Members shall have such other rights, powers and duties as are set forth in the Operating Agreement.

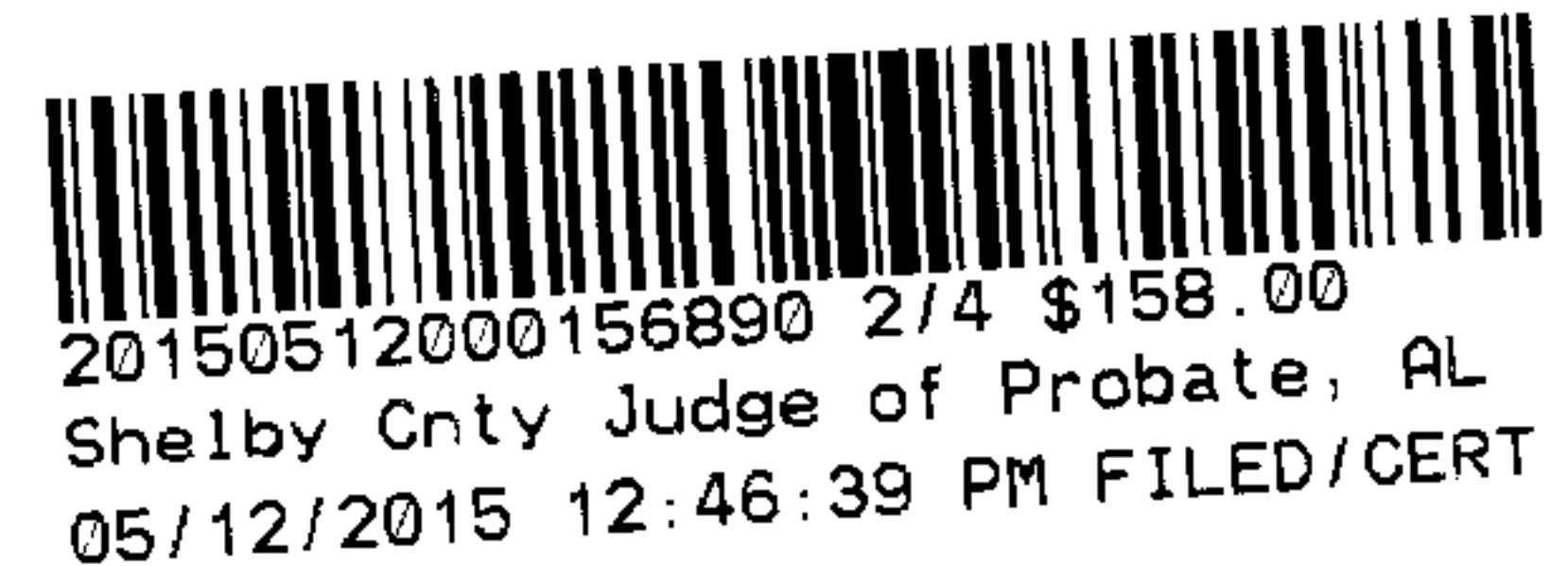

The Class A Member may permit the admission of additional Class A and Class B Members upon such terms and conditions as he may deem appropriate.


