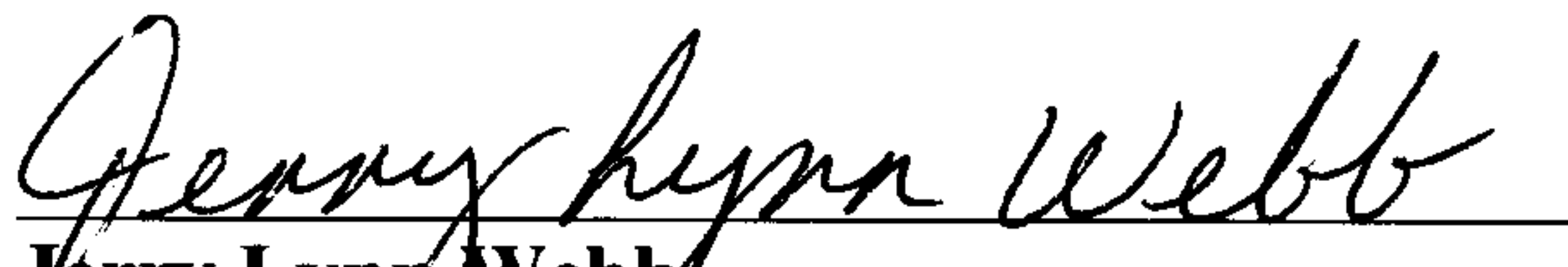

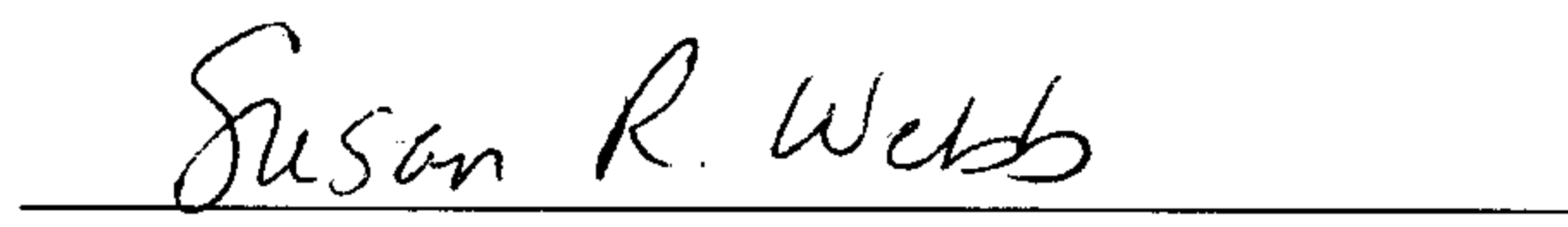
To have and to hold to the said grantee, as tenants in common, their heirs and assigns in fee simple, forever.

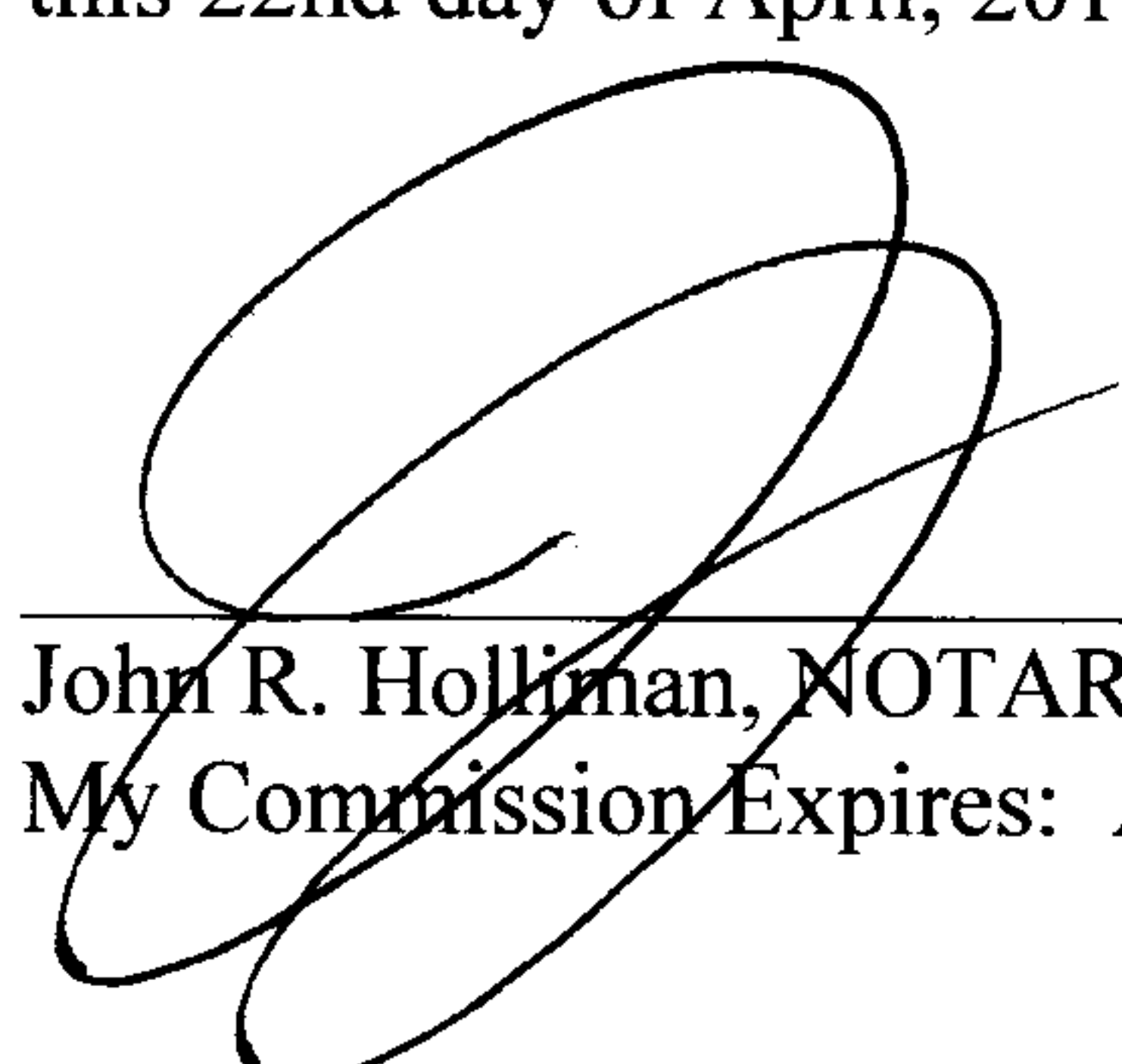

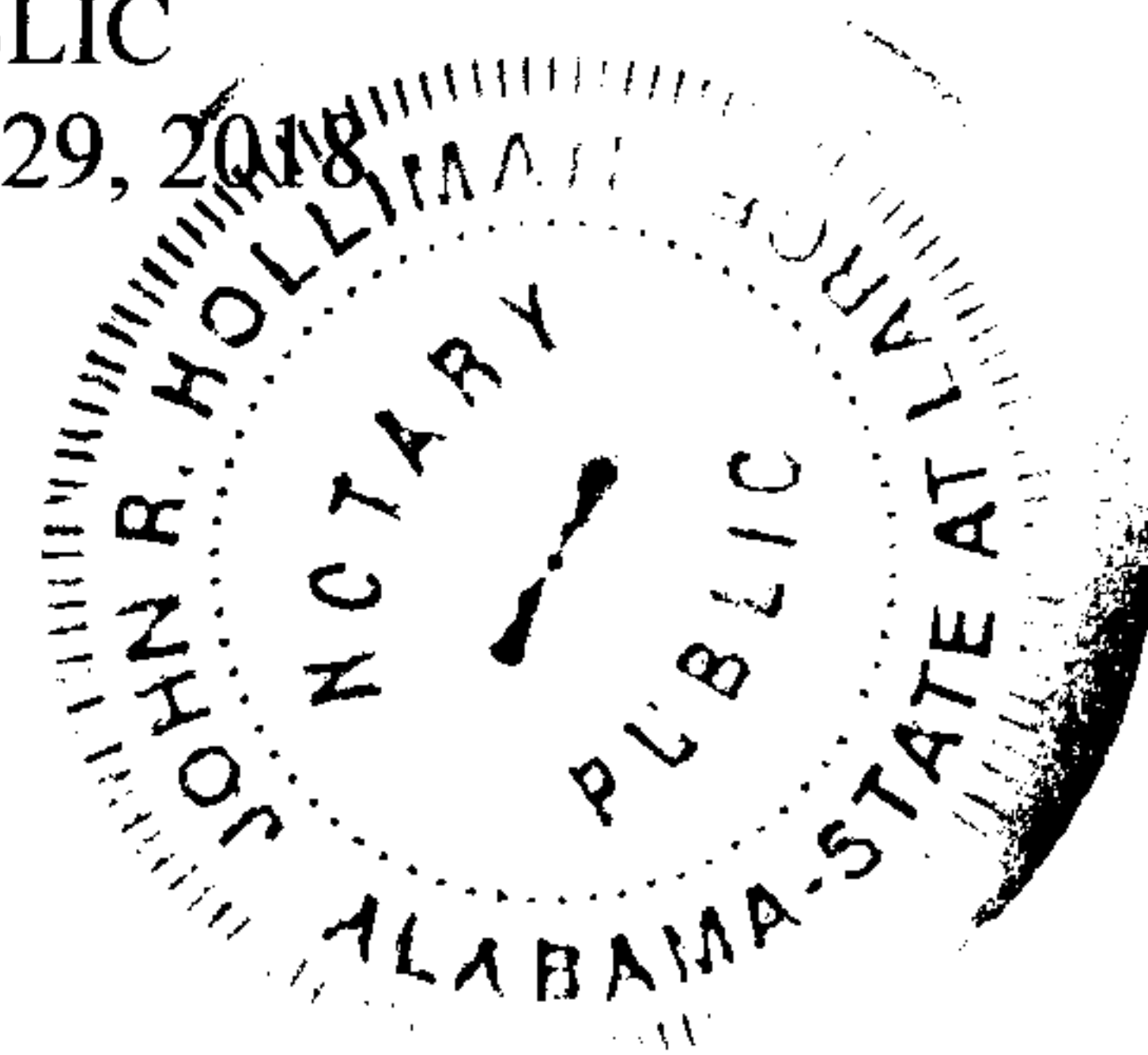
