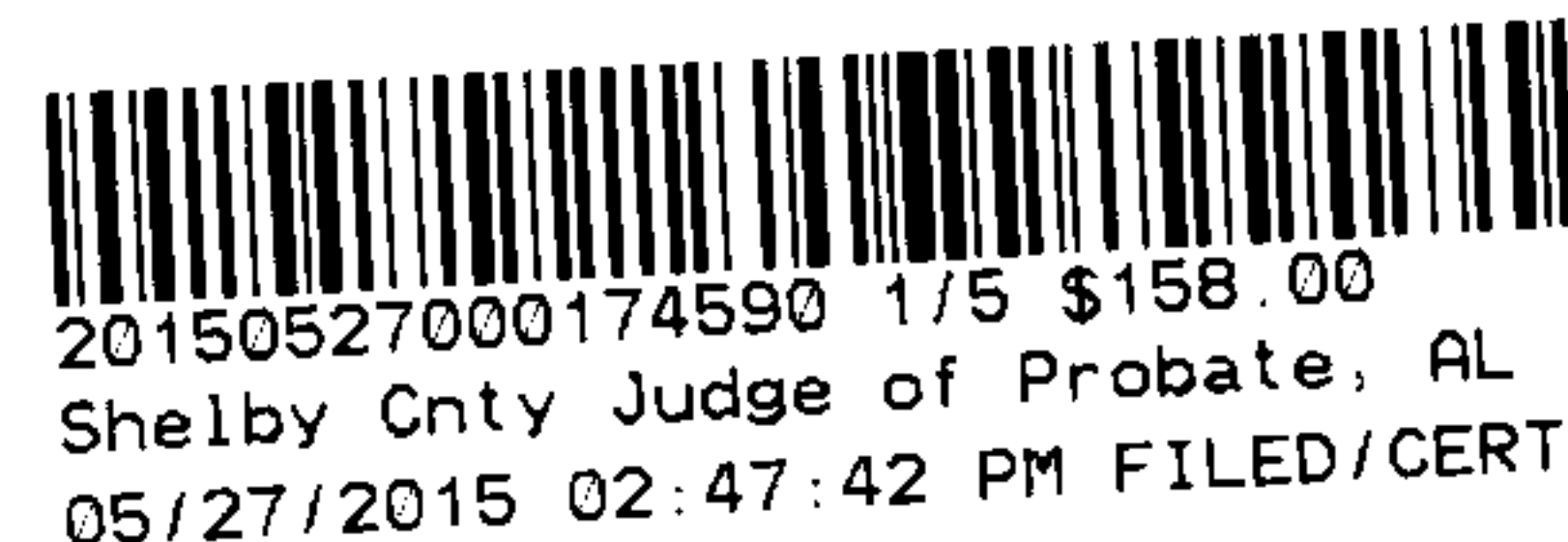


ARTICLES OF ORGANIZATION

OF

HENDERSON REALTY ADVISORS, LLC



The undersigned, for the purpose of forming a limited liability company under Title 10A, Chapter 5 of the Code of Alabama, as amended (the “Alabama Limited Liability Company Act”), hereby files this Articles of Organization with the Judge of Probate’s office in which the initial registered office of the limited liability company will be located, and hereby affirm the facts stated herein are true and correct:

ARTICLE I

Name

The name of the limited liability company is Henderson Realty Advisors, LLC (the “Company”).

ARTICLE II

Duration

The term of the Company shall be perpetual from the date of the filing of this Articles of Organization with the Judge of Probate’s office of the county in which the initial principal office of the Company is located, unless the Company is earlier dissolved in accordance with the operating agreement of the Company (if any) or the Alabama Limited Liability Company Act.

ARTICLE III

Purposes

The purpose or purposes for which the Company is organized is the transaction of any or all lawful business for which limited liability companies may be organized under the Alabama Limited Liability Company Act.

ARTICLE IV

Registered Office; Registered Agent

The location and mailing address of the initial registered office of the Company is 4010 Somerset Ridge, Birmingham, AL 35242, and the name of its initial registered agent at such address is Hunter H. Renfroe.

ARTICLE V

Initial Members

The names and addresses of the initial members of the Company are as follows:

ARTICLE VI

Organizer

The name and address of the organizer is Hunter H. Renfroe, 4010 Somerset Ridge, Birmingham, AL 35242.

ARTICLE VII

Admission of Additional Members

The initial members of the Company shall have the right to admit additional members to the Company but only upon the unanimous written consent of the then existing Members of the Company.

ARTICLE VIII

Cessation of Membership

Upon the cessation of membership of a Member in the Company, if there are no remaining Members, the Company shall be dissolved and the affairs of the Company shall be

wound up unless the holders of all financial rights in the Company agree in writing, within 90 days after the cessation of membership of said last Member, to continue the legal existence and business of the Company and to appoint one or more new members, and the legal existence and business of the Company is continued and one or more new Members are appointed in the manner stated in the operating agreement of the Company (if any) or this Articles of Organization.

ARTICLE IX

Managers

The Company shall be managed by no more than two managers, and the names and addresses of the persons or entities who are to serve as managers until their successors are elected and begin serving are as follows:

Internal Affairs

The regulation of the internal affairs of the Company shall be conducted in accordance with the provisions of the Company's operating agreement (if any), as the same may be amended from time to time, and the Alabama Limited Liability Company Act.

ARTICLE XI


Liability of Members and Managers

Members and managers of the Company are not liable under a judgment, decree or order of a court, or in any other manner, for a debt, obligation, or liability of the Company.
