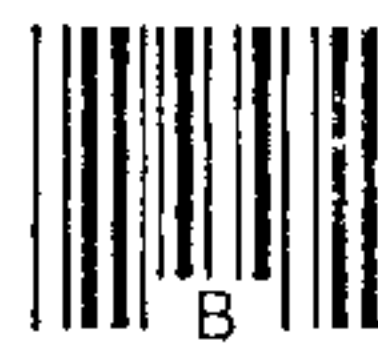
FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 27th day of August, 2007, John H. Thornton, an unmarried man, Hazel J. Thornton and Ollie V. 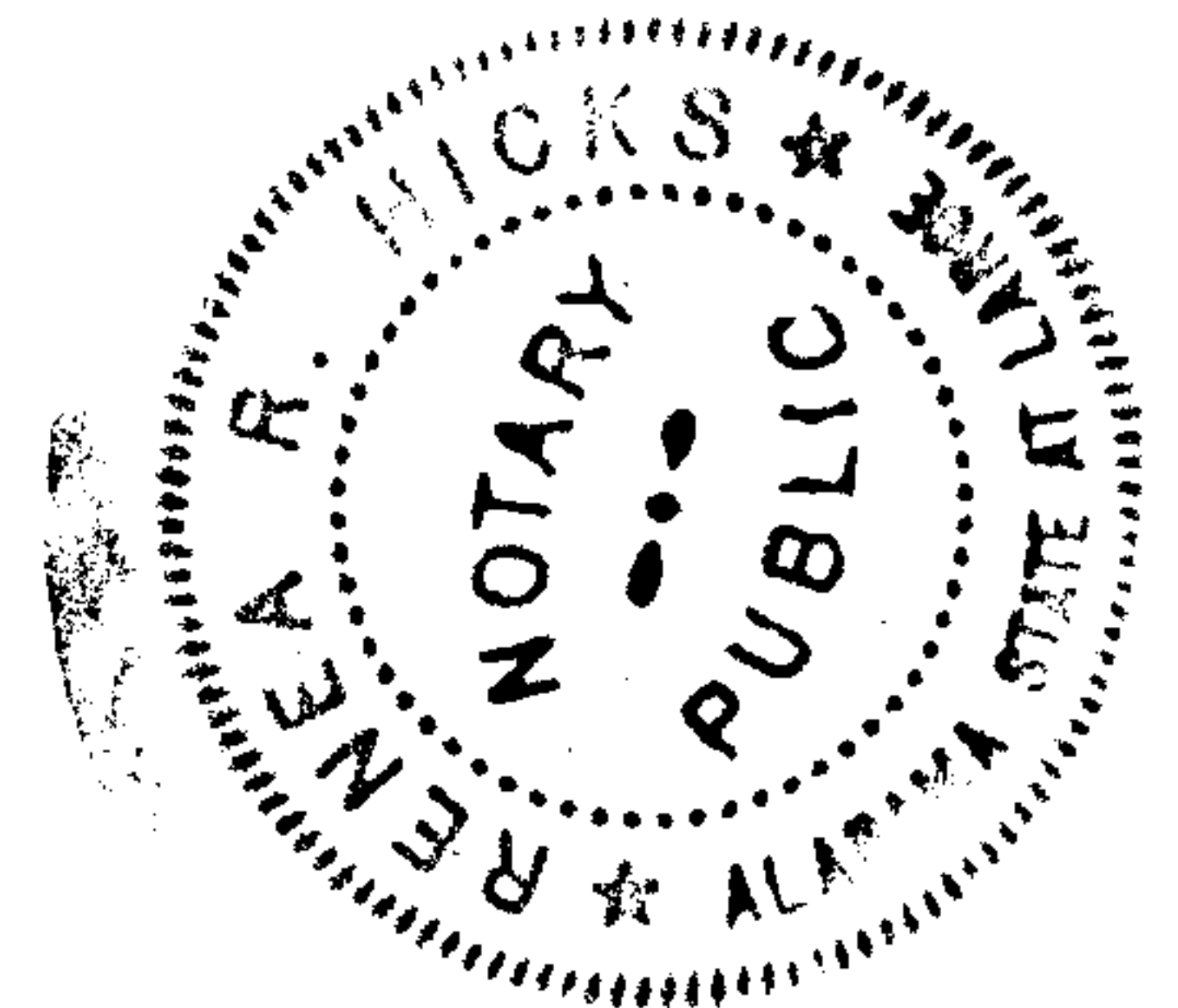
