Know all Men by these Presents: That, in consideration of One Hundred Sixty Thousand and No/100ths Dollars (\$160,000.00) and other good and valuable consideration to her in hand paid by the Grantee herein, the receipt of which is hereby acknowledged, **JENNIFER R. JACKSON, an unmarried person** (herein referred to as "Grantor") does by these presents grant, bargain, sell and convey unto **SHANNAN L. HOGGLE** (herein referred to as "Grantee") as sole owner, the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 8, according to the final plat of Cross Creek Subdivision, as recorded in Map Book 38, page 3, in the Probate Office of Shelby County, Alabama.

This conveyance is subject to subdivision restrictions, utility, drainage and sewer easements, and minimum setback lines, if any, applicable to the aforesaid property appearing of record in the Office of the Judge of Probate of Shelby County, Alabama. This conveyance is also subject to any prior reservation, severance or conveyance of minerals or mineral rights, taxes and assessments for the year 2015 and all subsequent years, and the following:

\$ 157,102.00 of the consideration herein was derived from a mortgage loan closed simultaneously herewith.


To Have and To Hold the aforegranted premises to the said Grantee as sole owner.



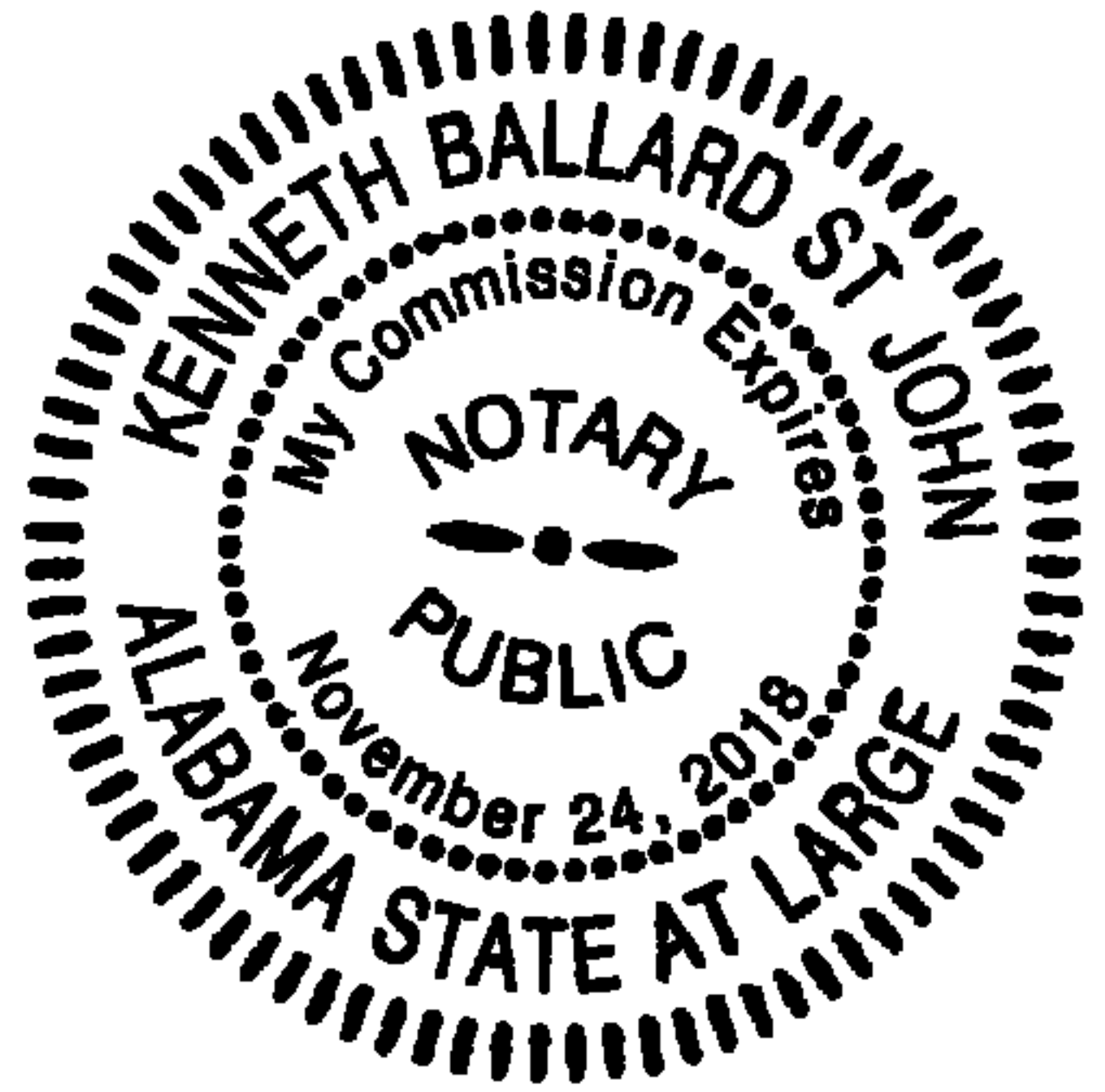
