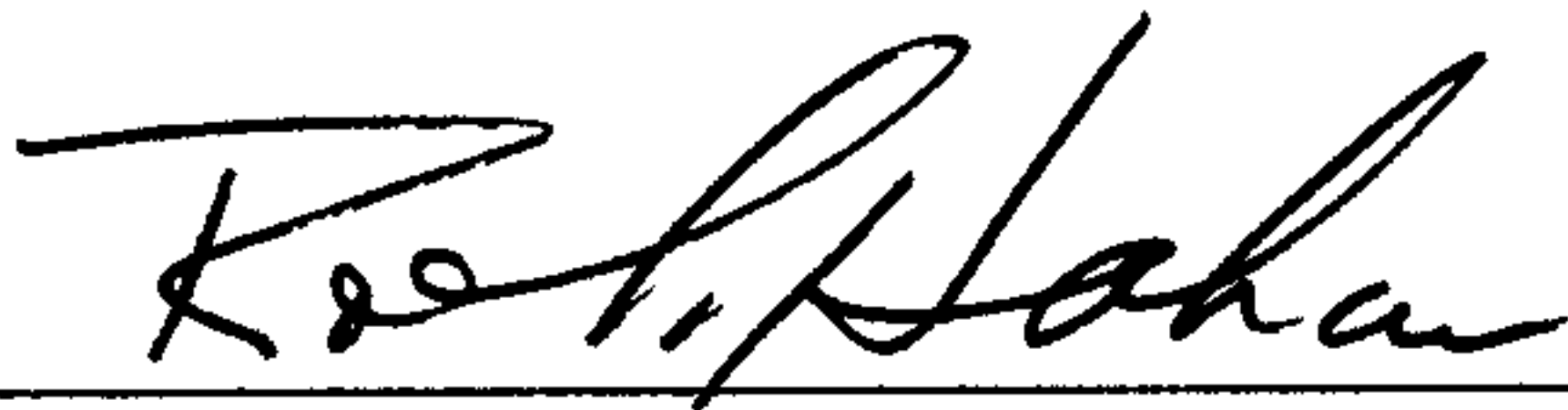
\$290,000.00 of the purchase price recited above is being paid by a mortgage loan

survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

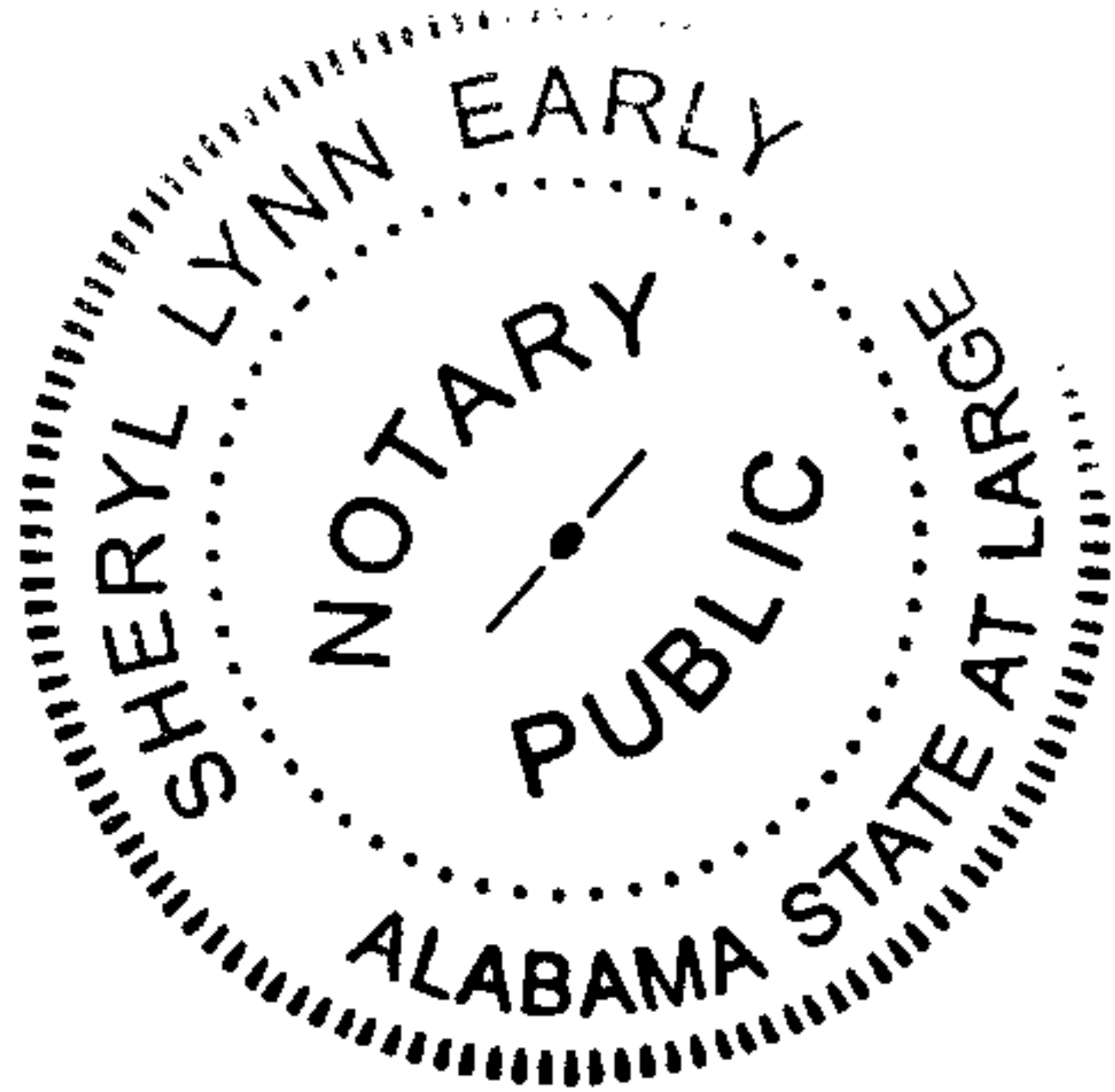
