**LIMITED POWER OF ATTORNEY**

My death shall not revoke nor terminate this Power of Attorney as to my attorney-in-fact nor any other person who, without actual knowledge of my death, acts in good faith under this Power of Attorney. I reserve the right to revoke this Power of Attorney at any time, but as to persons without actual knowledge that this Power of Attorney has been revoked, it shall remain in full force and effect until revoked by a writing signed by me and recorded in the office of the Probate Court of the County wherein I reside on the date hereof.

NON-REVOCATION AFFIDAVIT






