SAZERA INVESTMENTS, LLC**

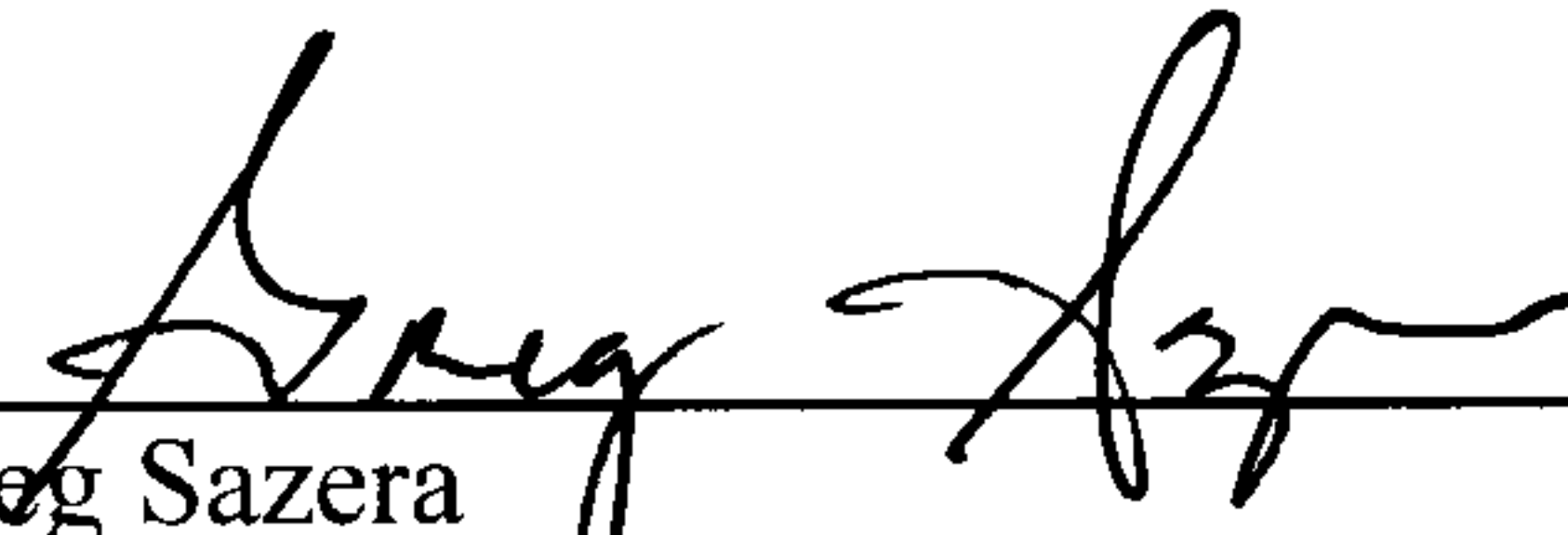
1. The name of the limited liability company is SAZERA INVESTMENTS, LLC.
