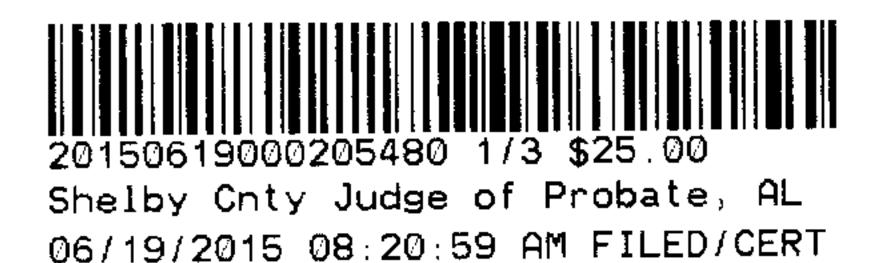
AUCTIONEER'S DEED



STATE OF ALABAMA COUNTY OF SHELBY

WHEREAS, KERRY SCOTT CARTER A/K/A KERRY S.
