On this May 6, 2015, That for and in consideration of <u>TWO HUNDRED FIFTEEN</u>

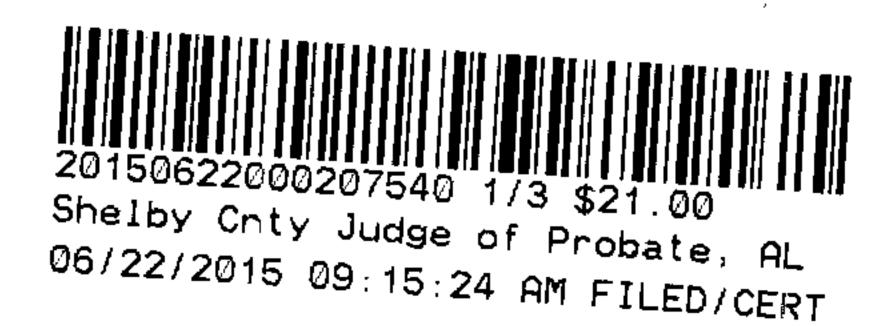

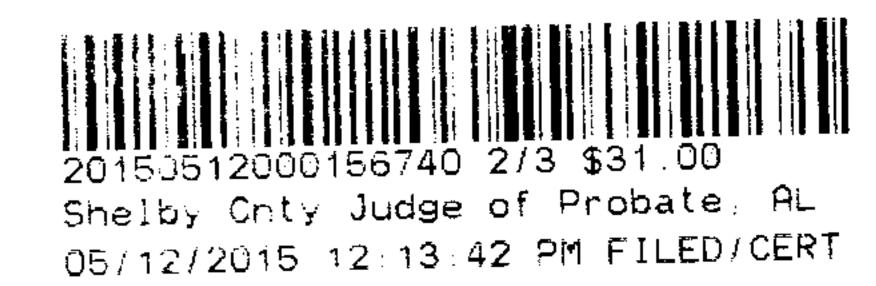
