FINAL JUDGMENT OF DIVORCE

THIS CAUSE coming on to be heard for a final order on the 26th day of March, 2015 on the pleadings on file in said cause. Upon consideration thereof, together with ore tenus testimony, it is

ORDERED, ADJUDGED and DECREED by the Court as follows:

1. DIVORCE

That the bonds of matrimony existing between the Plaintiff (Wife) and Defendant (Husband) are dissolved, and the said **Barri Brasher Burnett** is forever divorced from the said **Mark Walter Burnett** on the ground of incompatibility.

2. REMARRIAGE

Neither party shall marry again except to each other until sixty (60) days after the date of this Judgment of Divorce, and if an appeal is taken (which must be instituted within forty-two (42) days from this Judgment, or from the date that a post-trial motion is denied), then neither party shall again marry except to each other during the pendency of the appeal.

3. COURT COSTS

That the costs of court is taxed as paid.

4. MARITAL HOME

As previously set forth in this Court's Order dated November 13, 2014 the parties' marital residence shall continue to be for sale by a real estate broker selected by the Defendant at a price set by the real estate agent listing the property. The Plaintiff shall vacate the marital home within thirty (30) days and take all her personal property with her. Further, Plaintiff shall not further clutter or damage the marital home.

After Plaintiff vacates the marital home Defendant shall be permitted to take POSSESSION of said home to make such repairs within thirty (30) days after Plaintiff has vacated that are necessary or essential to place the said home for sale. Upon such sale, Defendant shall have any and all documented repairs reimbursed to him as set forth hereunder.

Upon the sale of said residence Plaintiff shall receive the entire or 100% of the net proceeds from the sale of said home. Net proceeds is defined as the gross sales price less deductions for the outstanding mortgage indebtedness, any property taxes, insurance (insuring the home), commission, closing cost, documented repairs as stated above and payment of attorney's fees set forth below. Defendant shall make the monthly mortgage payments during the pendency of said sale.

This Court hereby retains jurisdiction for the implementation and execution of this Paragraph 4.

5. VEHICLES

(a) Plaintiff is AWARDED the Chrysler Sebring automobile and Defendant is divested of any and all right, title or interest therein. Defendant shall execute any and all documents necessary

to effectuate title to said Sebring over unto the Plaintiff. Any indebtedness on said Sebring shall be paid by Defendant. Plaintiff shall be responsible for carrying insurance on said vehicle.

(b) All other vehicles of the marriage are AWARDED to Defendant. Plaintiff is divested of all right, title and interest in and to said vehicles. Defendant shall be responsible for any and all indebtedness owed on such vehicles and hold Plaintiff harmless therefrom.

6. OTHER PERSONAL PROPERTY

Plaintiff is hereby AWARDED those items listed on Exhibit A attached hereto and made a part hereof. All other items of personal property not heretofore awarded are awarded to Defendant.

7. DEBTS

Except as specifically set forth herein, Defendant shall be responsible for the marital debts.

8. HARASSMENT

Neither party shall harass, annoy or intimidate the other party or otherwise interfere with the other party's everyday activities.

9. ALIMONY

This Court hereby reserves the issue of periodic alimony.

10. ATTORNEY'S FEES

(a) Richard Shuleva, attorney for Plaintiff /Wife is AWARDED an attorney's fee of Six Thousand Dollars (\$6,000.00) as said amount was testified to in open court without objection; the Court finds this fee is reasonable in this case and said sum is to be paid out of the share of the net proceeds awarded to Plaintiff/Wife from the sale of the house. Said funds are to be disbursed directly to the Honorable Richard C. Shuleva at the closing of the house. This order shall be

interpreted to create a lien upon the marital residence in the amount of Six Thousand Dollars (\$6,000.00), and can be recorded in the Office of the Judge of Probate.

(b) S. Phillip Bahakel, attorney for the Defendant/Husband, is hereby AWARDED an attorney's fee in the amount of Eleven Thousand Four Hundred Ten Dollars (\$11,410.00) as said amount was verified by the Defendant/Husband as the amount that was due and payable for his attorney's fees; the Court finds this fee is reasonable in this case and said sum is to be paid out of the share of the net proceeds awarded to the Defendant/Husband from the sale of the house. Said funds are to be disbursed directly to the Honorable S. Phillip Bahakel at the closing of the house. This order shall be interpreted to create a lien upon the marital residence in the amount of Eleven Thousand Four Hundred Ten Dollars (\$11,410.00), and can be recorded in the Office of the Judge of Probate.


