

## ARTICLES OF ORGANIZATION OF

#### ARTICLE I NAME

## ARTICLE V PRINCIPAL PLACE OF BUSINESS


The location and street address of the principal place of business shall be:

## ARTICLE VIII ADDITIONAL MEMBERS


The initial members shall have the right to admit additional members upon unanimous consent and agreement of the original members.
