ARTICLE I NAME

ARTICLE V PRINCIPAL PLACE OF BUSINESS

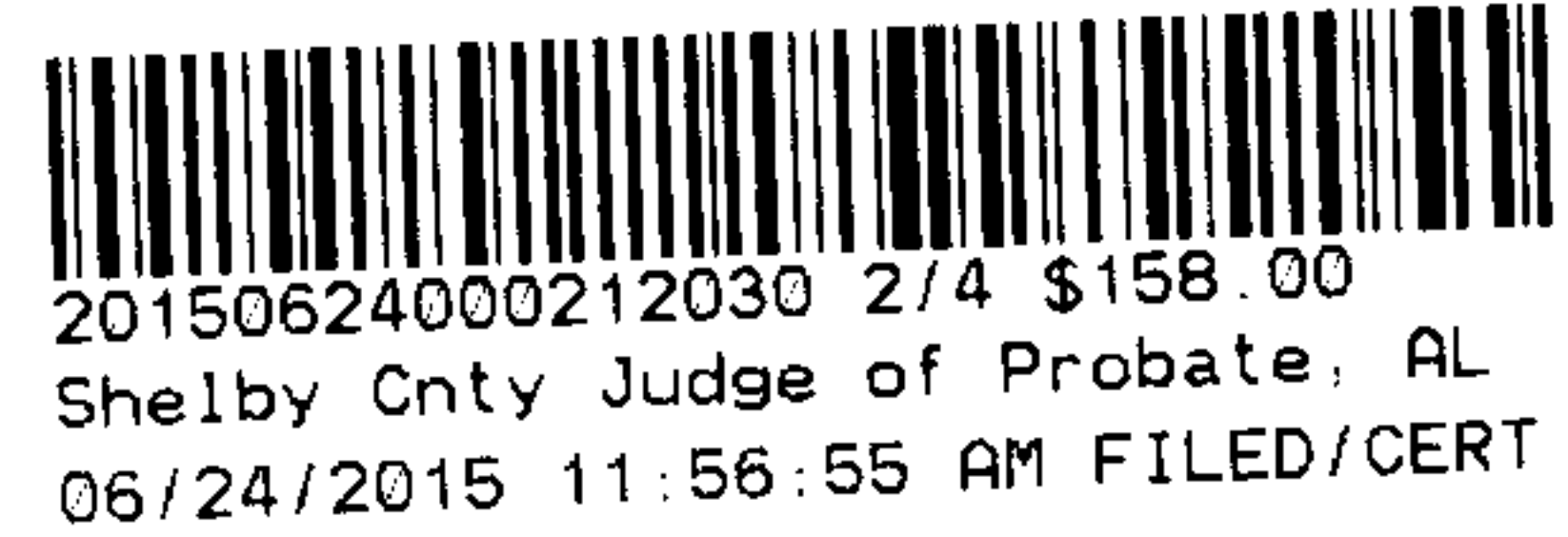


**ARTICLE VIII
