

MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, heretofore on, July 20, 2006, to wit, H. Adam Haas and Alicia M. Haas, husband and wife, executed and delivered to Mortgage Professionals, Inc., a mortgage conveying to Mortgage Professionals, Inc., the property hereinafter described, which said mortgage was given to secure an indebtedness there in mentioned, and which Mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, under Instrument Number 20060721000353410; said Mortgage having been transferred and assigned by Mortgage Professionals, Inc. to Trustmark National Bank by virtue of that certain Assignment of Mortgage dated July 20, 2006 and recorded in said Probate Office under Instrument Number 20060721000353420; said Mortgage having been further transferred and assigned by Trustmark National Bank to Regions Bank dba Regions Mortgage by virtue of that certain Corporate Assignment of Mortgage dated February 17, 2010 and recorded in said Probate Office under Instrument Number 20100308000066150; and

Haas, by Dan Head, the auctioneer making said sale, and Dan Head, as said auctioneer, for and in consideration of the premises and the sum of One Hundred Twenty-Three Thousand Nine Hundred Thirty-Five and 61/100 Dollars (\$123,935.61), applied by Regions Bank dba Regions Mortgage, as Assignee, to the indebtedness secured by said mortgage, do hereby Grant, Bargain, Sell and Convey unto the said, Federal Home Loan Mortgage Corporation, organized and existing under the laws of the United States of America,
