The Limited Liability Company has been organized for the following purpose(s):

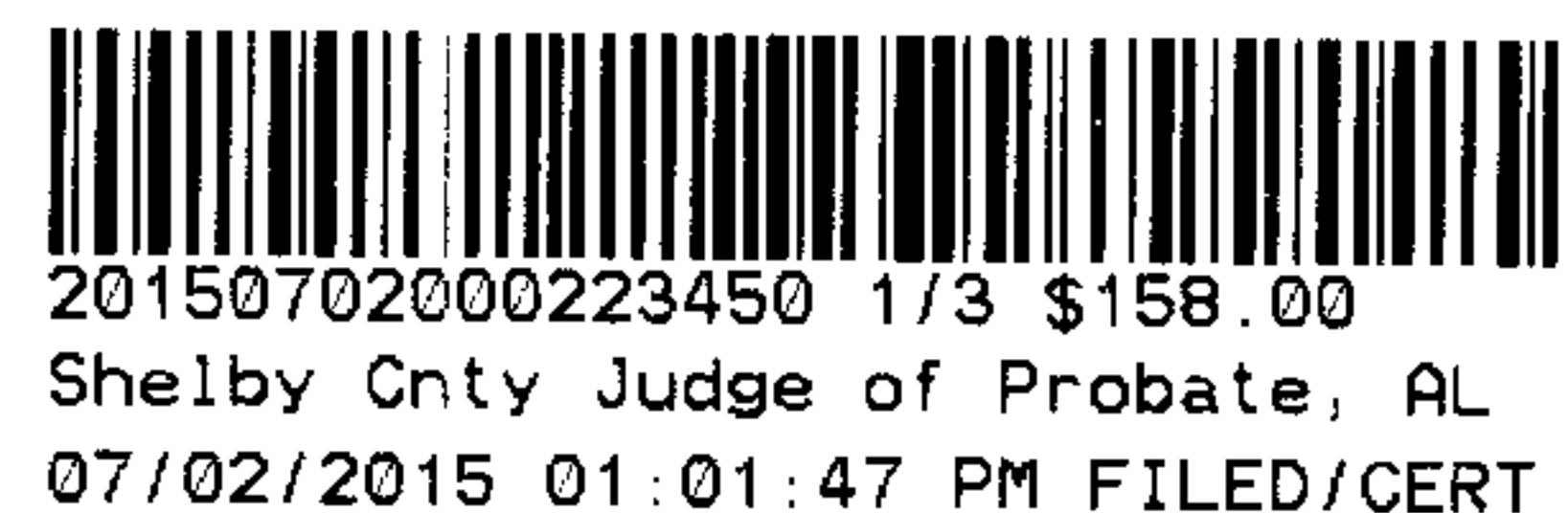

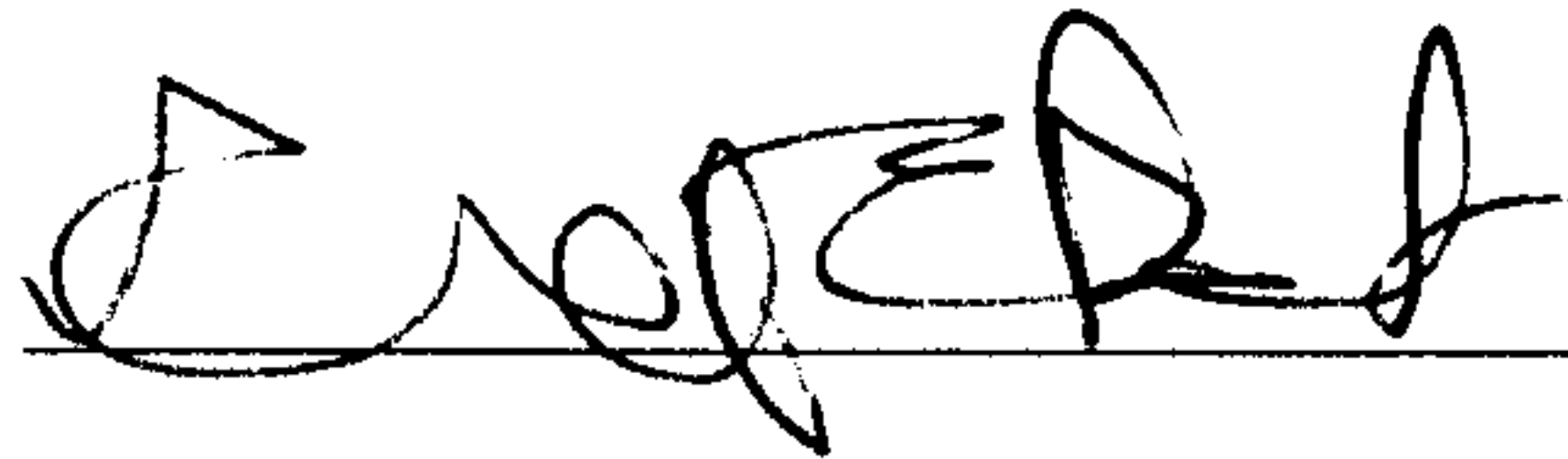

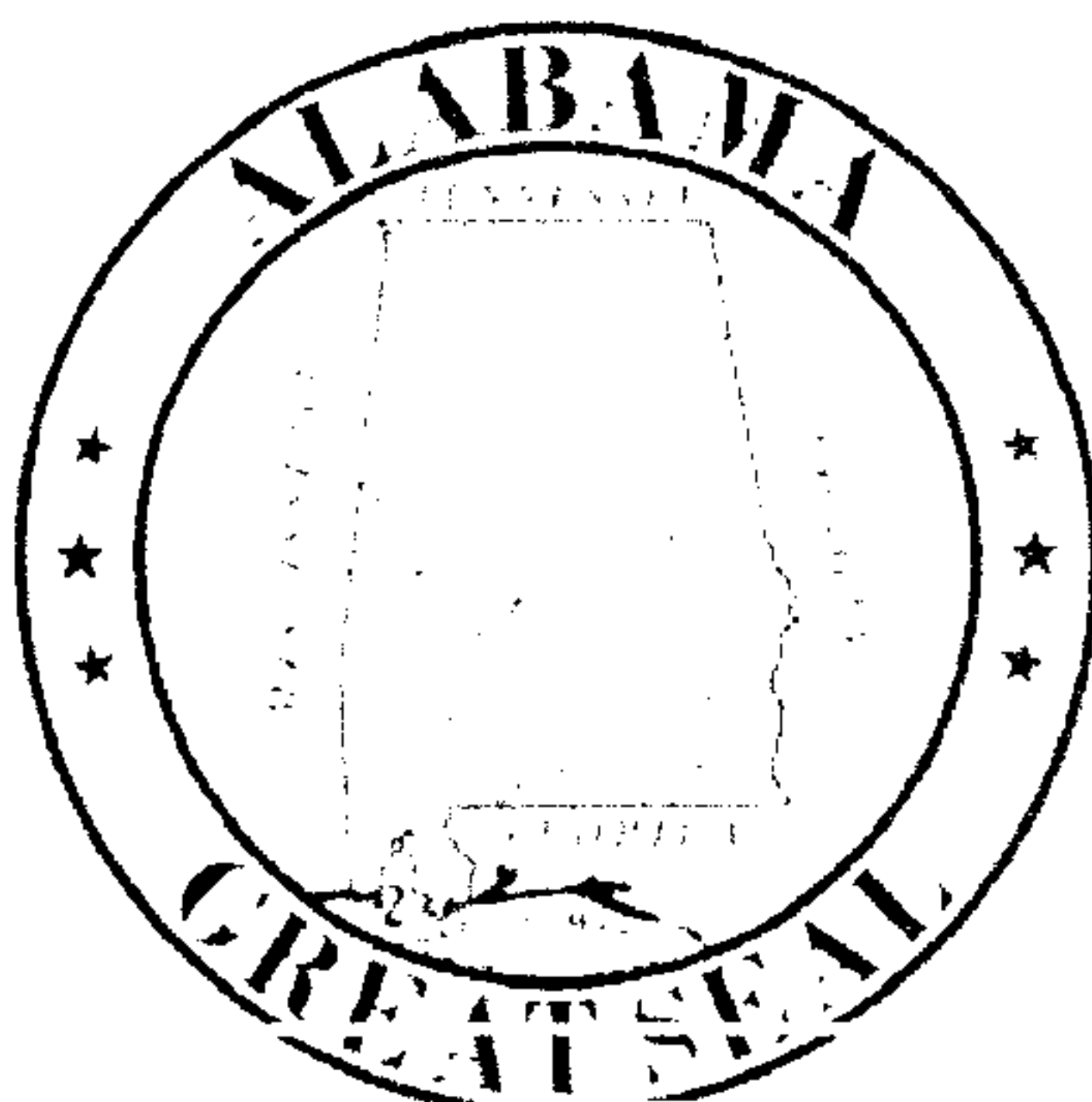
