WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

On this June 26, 2015, That for and in consideration of TWO HUNDRED SEVENTY SEVEN THOUSAND AND NO/100 (\$277,000.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned DONALD K. BONNER, an unmarried man, (herein referred to as "Grantor"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the Grantees, THANH H. DO. and HUE T. DO and TRUC T. DOBUI, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantor's interest in the following-described Real Estate situated in, SHELBY COUNTY, ALABAMA, to wit:






