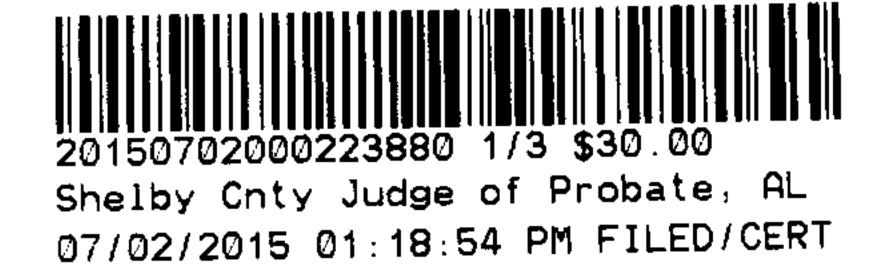

WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS,

On this June 30, 2015, That for and in consideration of ONE HUNDRED NINETY SEVEN
THOUSAND AND NO/100 (\$197,000.00) DOLLARS, and other good and valuable consideration, this
day in hand paid to the undersigned GRANTOR SYLVIA TSO, AS PERSONAL REPRESENTATIVE
OF THE ESTATE OF RAYMOND CHEE CHEUK TSO A/K/A RAYMOND TSO, DECEASED
(SHELBY COUNTY CASE #PR-2014-000220), (herein referred to as "Grantor"), in hand paid by the
Grantees herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant,
bargain, sell and convey unto the Grantees, JOSHUA SETH MOREY and ALLISON MOREY,
(herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the
survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the
