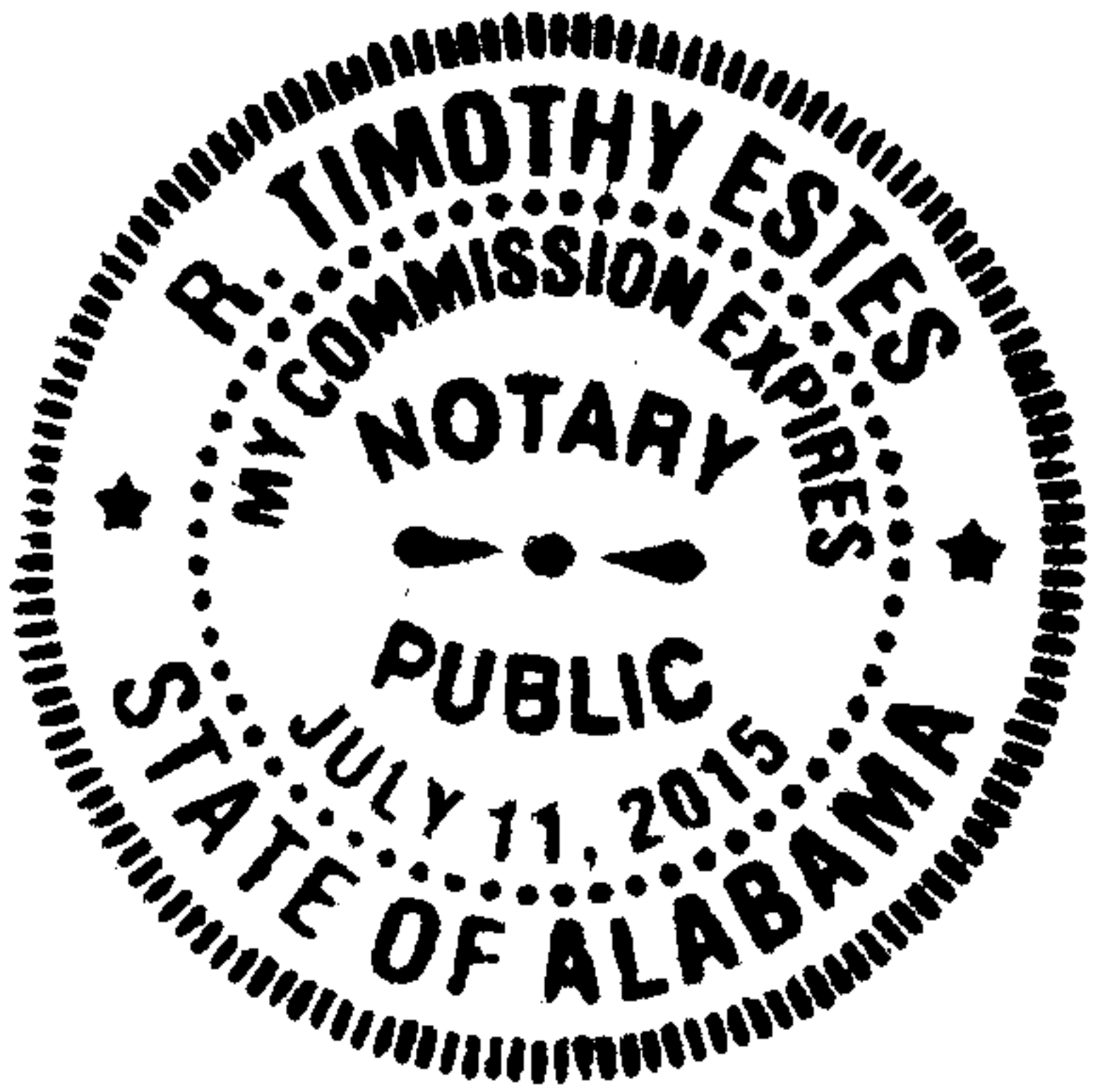

TEN MILLION (\$10,000,000.00) DOLLARS

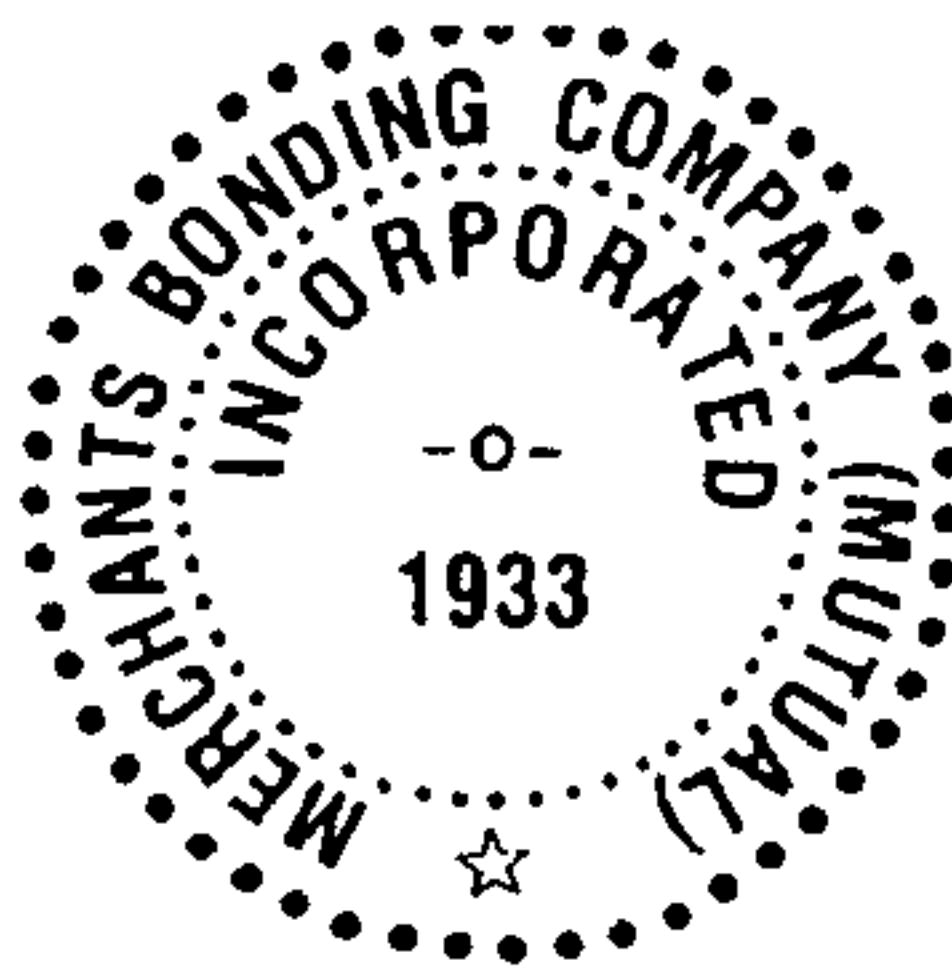
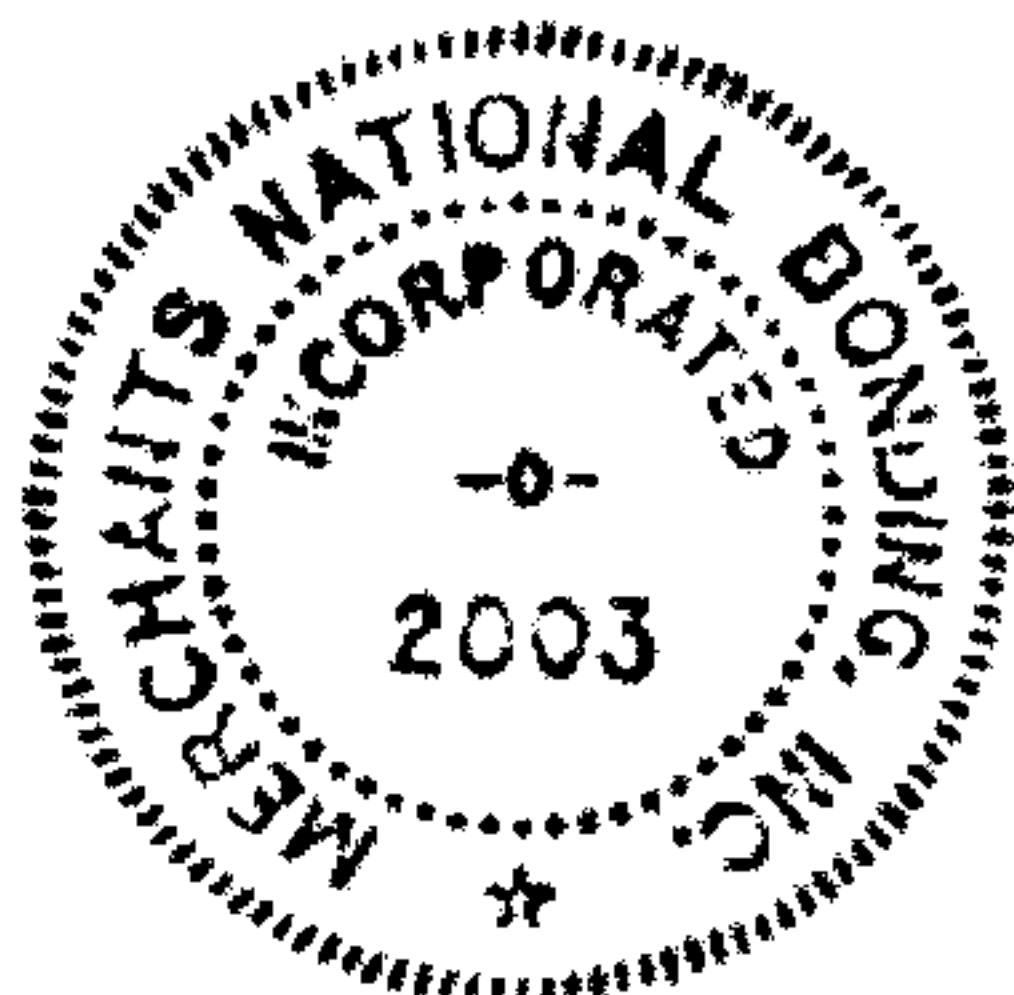
