

ARTICLES OF ORGANIZATION

ARTICLE VIII


Manager Managed

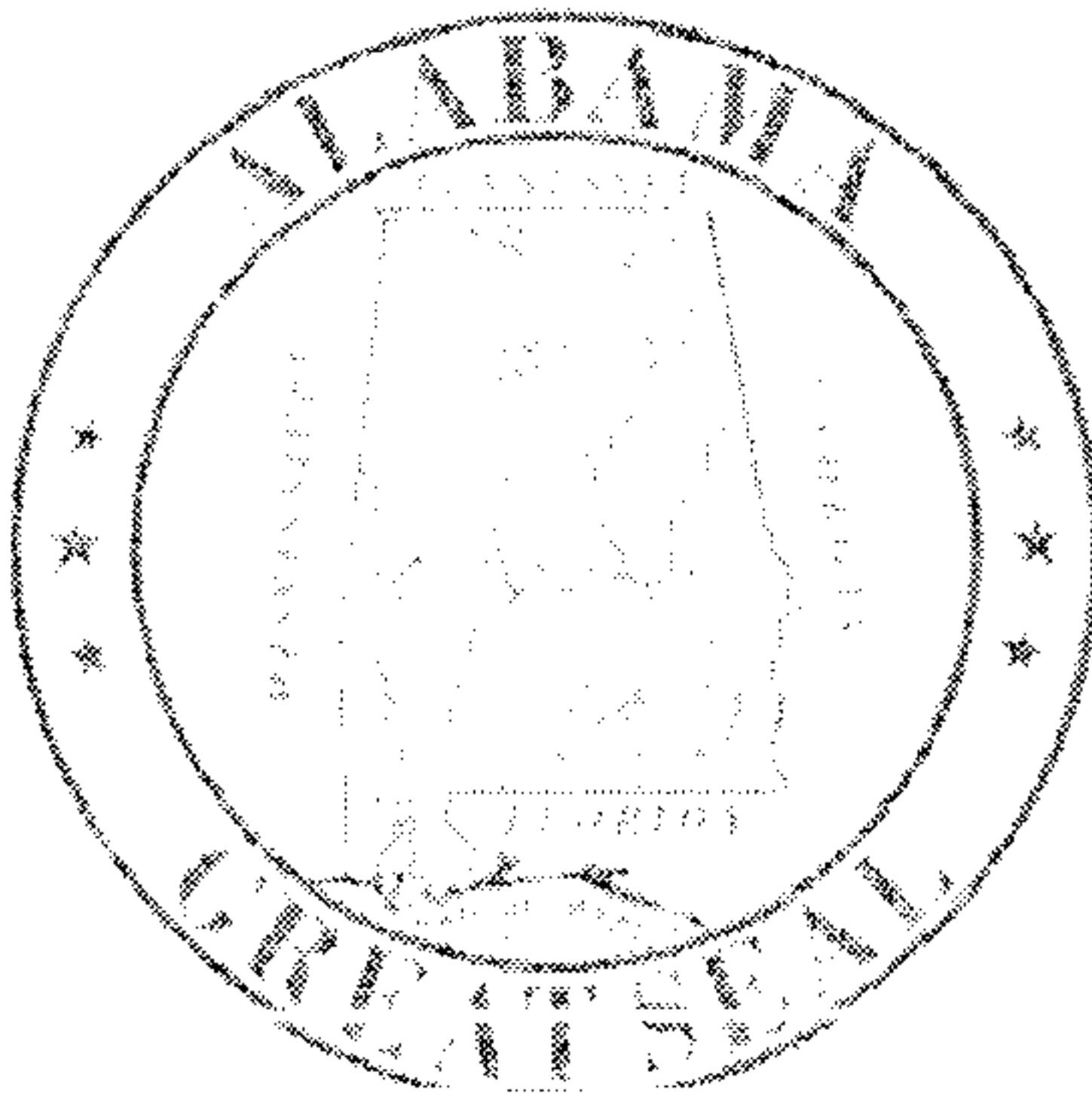
