more), the following described real estate, situated in Shelby County, Alabama, to-wit:

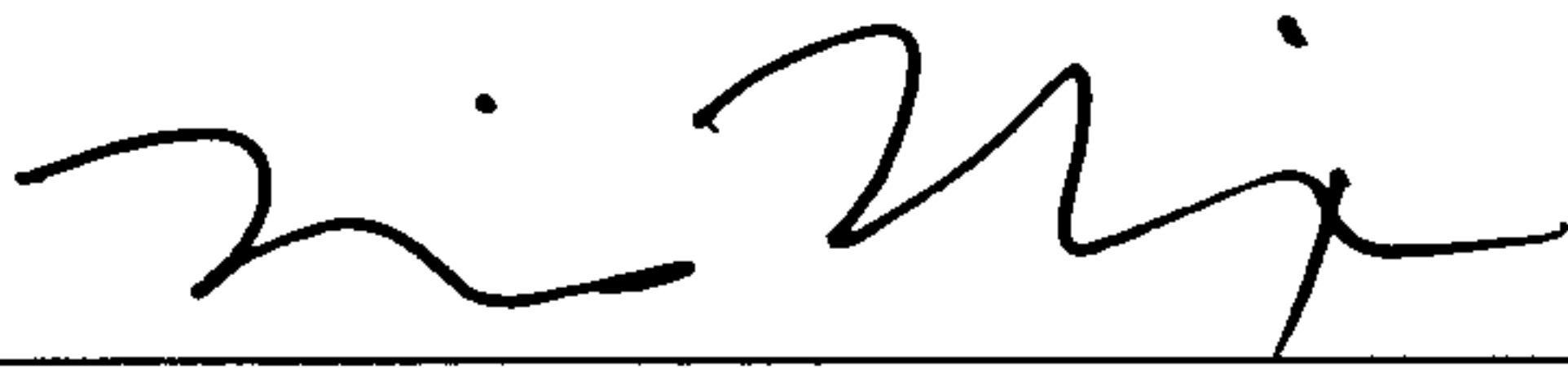

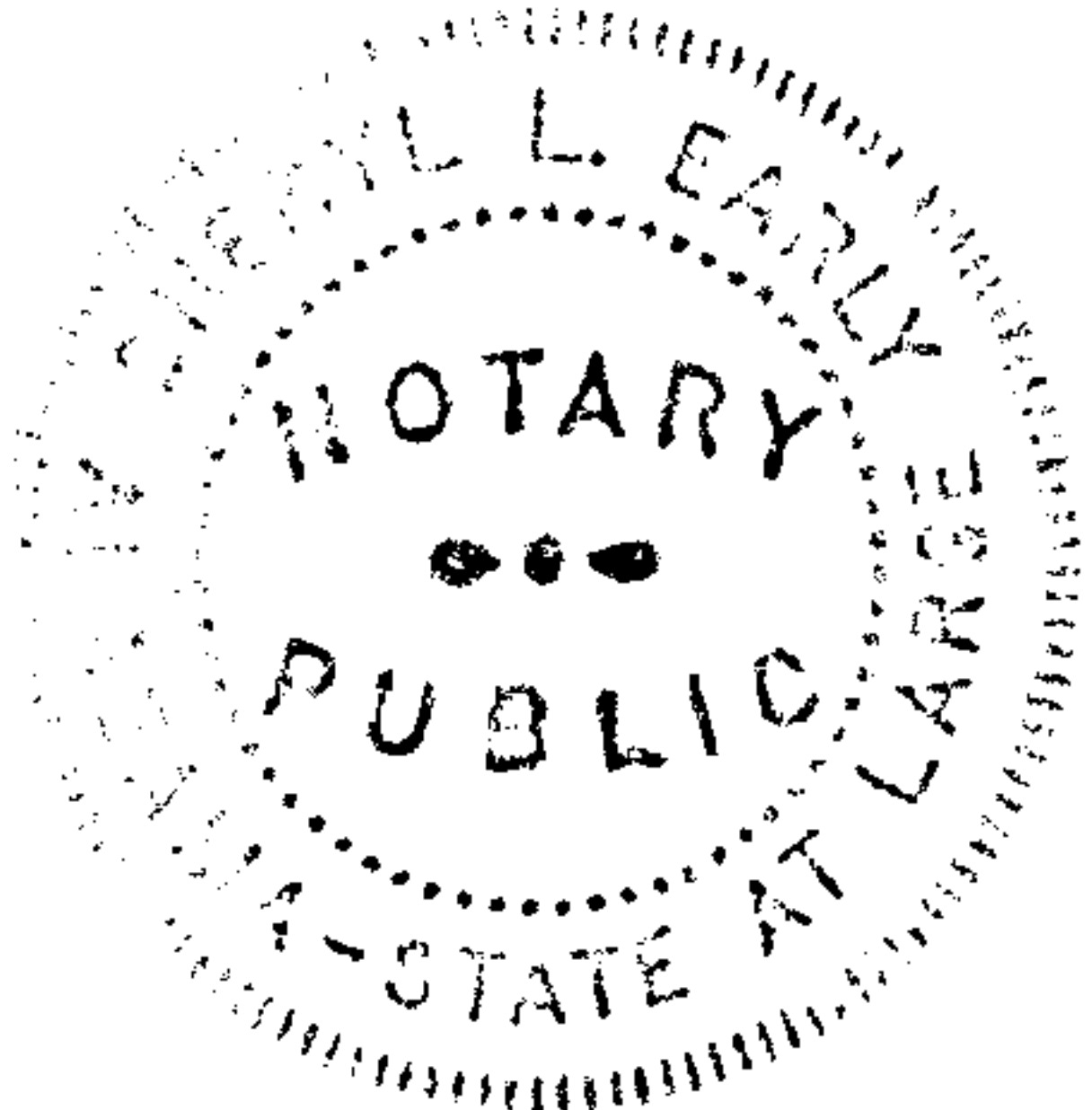

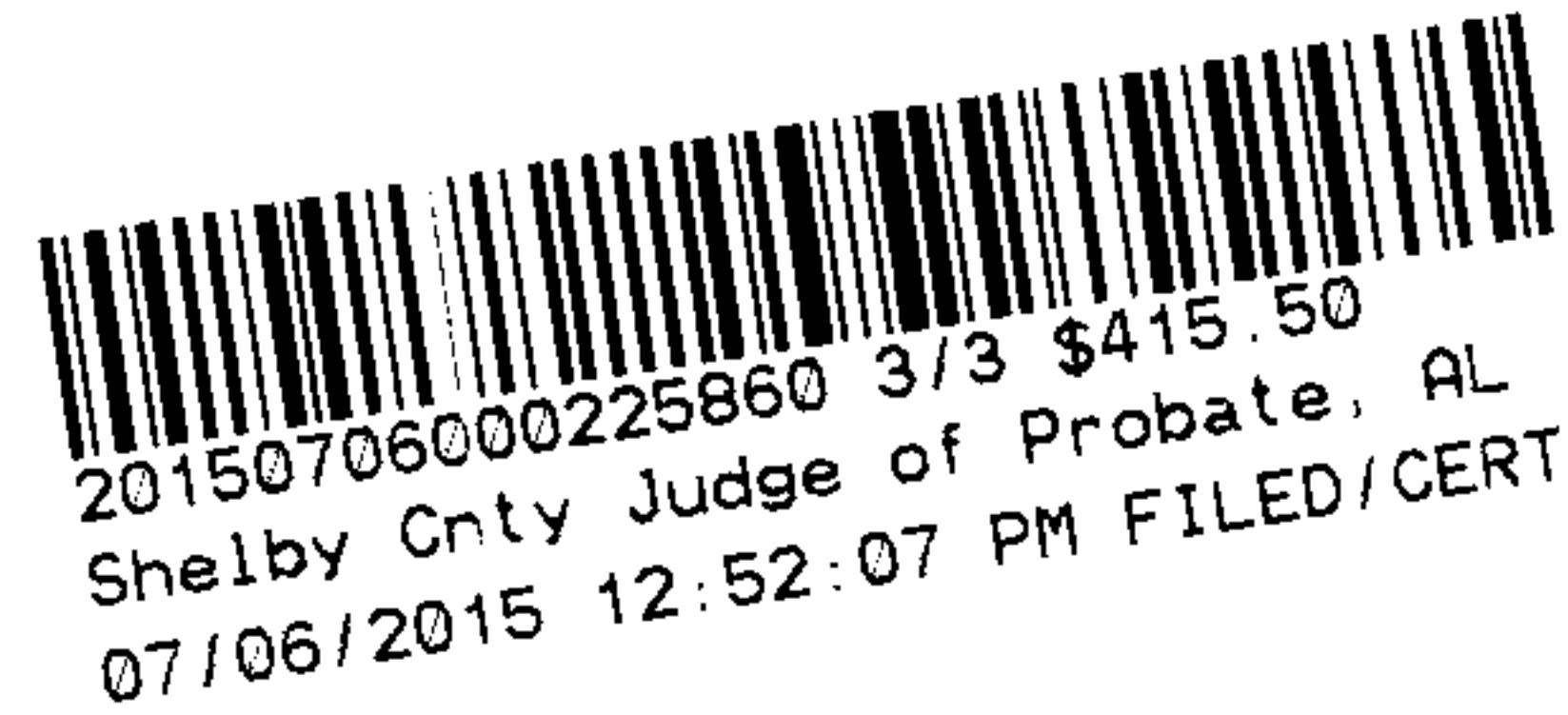
