FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on July 14, 2006, to-wit: George Vowell, Jr., a married man and Cindy Vowell, a married woman, executed a mortgage to ABN AMRO Mortgage Group, Inc., its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on August 14, 2006, in Instrument No. 20060814000395160, in the Office of the Judge of Probate, Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; and

redeem as provided by the laws of the State of Alabama, also subject to prior liens, ad valorem taxes, easements and restrictions of record.

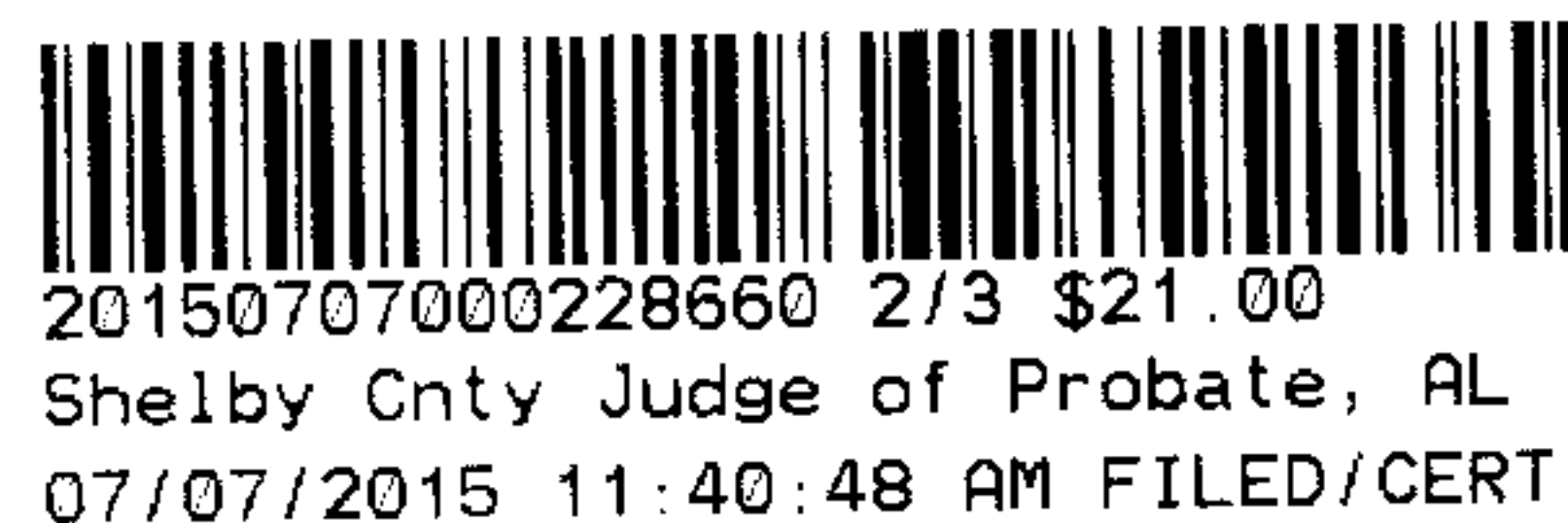
