

ARTICLE I: Name

The name of the Limited Liability Company is GDL LOGISTIC SERVICES, LLC ("The Company")

ARTICLE II: Duration

The Company shall have duration from the date of organization until January 1, 2110 unless it is dissolved and its affairs wound up in accordance with the Alabama Limited Liability Company ("The Act")

ARTICLE IV: Registered Office, Registered Agent




