
Whereas, an execution issued from the State of Alabama Department of Revenue, against Stacey A. Franklin in favor of State of Alabama Department of Revenue on a judgment rendered in said Court at the April Term thereof, 2015, for the sum of Three thousand nine hundred seventy three and 42/100 ----- Dollars, besides cost of suit, which said execution came into my hands, as Sheriff of said County, on the 5th day of May, 2015, to execute and return according to law; and, whereas, also, divers other executions issued from the n/a were also placed in my hands, against said n/a to execution and return according to law, as will appear by reference to the records of said court, by virtue of which execution above recited, as also the other said executions, I did, as Sheriff aforesaid, levy upon the following as the property of said Stacey A. Franklin, to wit:

Lot 14, according to the Survey of Oak Park Highlands, Sector 3, as recorded in Map Book 26, page 136, in the Probate Office of Shelby County, Alabama.

Of which said levy then and there notice was given said defendant personally, and the said property so levied on, after having been duly advertised for sale, by giving thirty days' previous publication of the time, place, and terms of sale in the Shelby County Reporter, a newspaper published in Columbiana, Alabama, and also by posting at the Courthouse door of said County an advertisement of said sale for thirty days previous, was offered for sale at the Shelby County Courthouse in the City of Columbiana, Alabama between the legal hours of sale, on the 3rd Monday in June, 2015, at which said sale State of Alabama Department of Revenue became the purchaser of said property so levied on as aforesaid, for the sum of Six hundred ninety and 45/100 ----- Dollars, being the highest, best, and last bid for the same.

Now, therefore, Know all Men by the Presents, That for and in consideration of the premises, and of the payment by said State of Alabama Department of Revenue of the sum of Six hundred ninety and 45/100 ----- Dollars, the receipt of which is hereby acknowledged, I do hereby convey, transfer, and set over to the said State of Alabama Department of Revenue all the legal right, title, interest, and claim which the said Stacey A. Franklin had and held in and to the foregoing described premises.
