**WARRANTY DEED**

KNOW ALL MEN BY THESE PRESENTS, That in consideration of Three Hundred Twenty-Four Thousand Nine Hundred and 00/100 Dollars (\$324,900.00) and other good and valuable consideration the receipt and sufficiency whereof is hereby acknowledged, I, **DIANNE W. SYX, AN UNMARRIED WOMAN** (herein referred to as GRANTOR) does by these presents grant, bargain, sell and convey unto **MARCI PRICE AND DAVID PRICE** (herein referred to as GRANTEE, whether one or more), as joint tenants with right of survivorship, the following described real estate, situated in Shelby County, Alabama, to-wit:

**NOTE:** \$259,920.00 of the purchase price is being paid by the proceeds of a first mortgage loan executed and recorded simultaneously herewith.




