Know All Men by These Presents: That in consideration of **Three hundred forty two thousand nine hundred seventy five and no/100 (\$342,975.00)**, to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Donovan Builders, LLC** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Clinton J.
