

AMENDMENT TO DECLARATION OF EASEMENTS

THIS AMENDMENT TO DECLARATION OF EASEMENTS is entered into the 17 day of July, 2015 by SCP BUILDING 4, LLC ("SCP") and provides as follows:

SCP is the owner of Lot 2C, Graham's Resurvey of Lot 2, Shelby Commerce Parc as recorded in Map Book 35, Page 18 in the Shelby County Probate Office.

In that Declaration of Easements recorded in Volume 20051114000593080 in the Shelby County Probate Office (the "Declaration"), a non-exclusive Maneuvering Easement was granted to Lot 2C over a portion of Lot 2B as more particularly described in the Declaration and as shown on Exhibit F to the Declaration.

WHEREAS SCP desires to release any right it has to the Maneuvering Easement as set forth herein.

NOW, THEREFORE, in consideration of Ten Dollars and 00/100 (\$10.00) and other good and valuable consideration, the sufficiency of which is hereby acknowledged, SCP hereby amends the Declaration as follows:

- 1. Section 1(f) is hereby deleted in its entirety and SCP hereby releases any and all rights it might have in the Maneuvering Easement set forth in the Declaration.
- 2. Exhibit F to the Declaration setting forth the location of the Maneuvering Easement is hereby deleted.
- 3. Except as amended herein, the terms of the Declaration are incorporated herein by reference.
