WHEREAS, heretofore on 10/16/08, **Kristen P. 

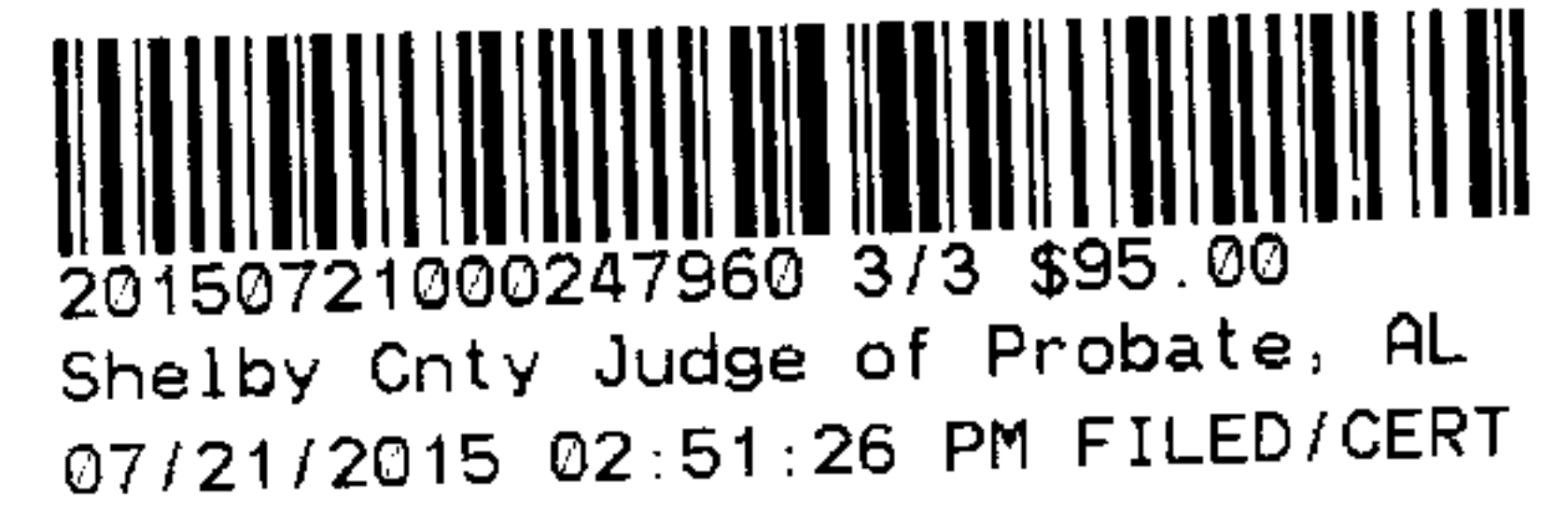
