KNOW ALL PERSONS BY THESE PRESENTS: That HENRY SIMWANZA, an unmarried man, did, on to-wit, February 23rd, 2010, execute a mortgage to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Renasant Bank, which mortgage is recorded in Instrument No. 20100226000058010, et seq., in the Office of the Judge of Probate of Shelby County, Alabama; said mortgage being lastly assigned to BANK OF AMERICA, N.A. successor by merger to BAC Home Loans Servicing, LP fka Countrywide Home Loans Servicing, LP by instrument recorded in Instrument No. 20120710000245980 in said Probate Court records; and






