The corporation shall have members.

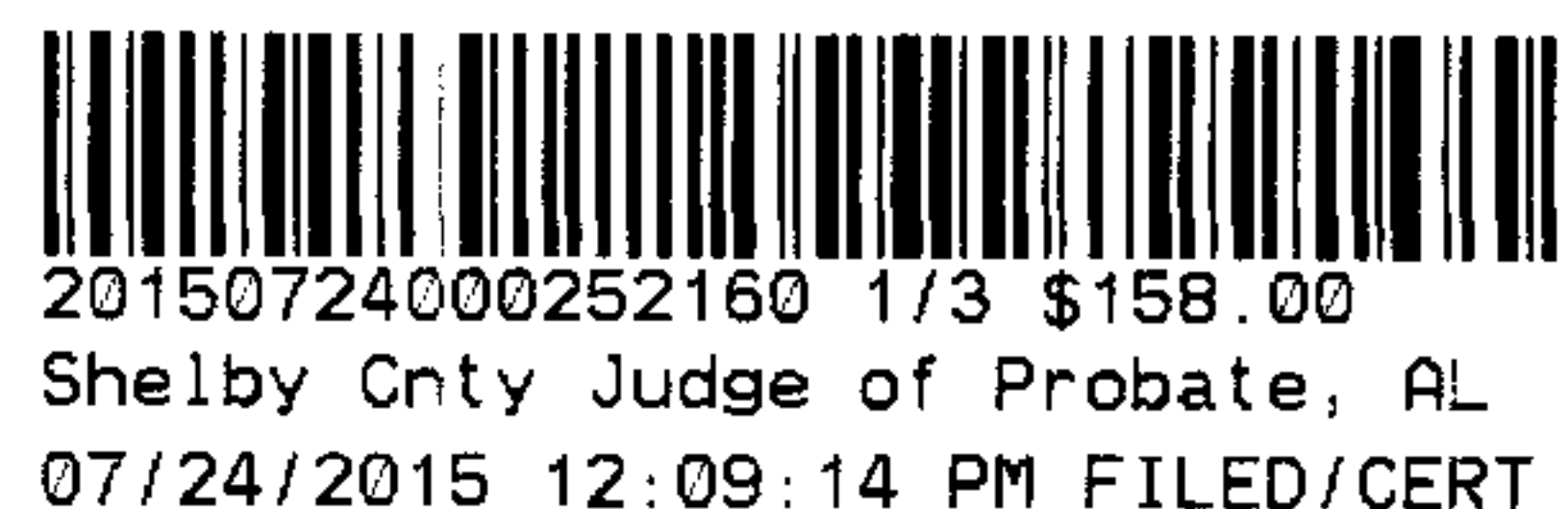
