Blankenship, a Married man** (herein referred to as **Grantor**) grant, bargain, sell and convey unto **Landa Dawkins and Donald Dawkins** (herein referred to as **Grantees**), the following described real estate, situated in: **SHELBY County, Alabama**, to-wit:


SUBJECT TO:


