JANE PHIPPS IS ONE AND THE SAME AS JANE W. TANNER.

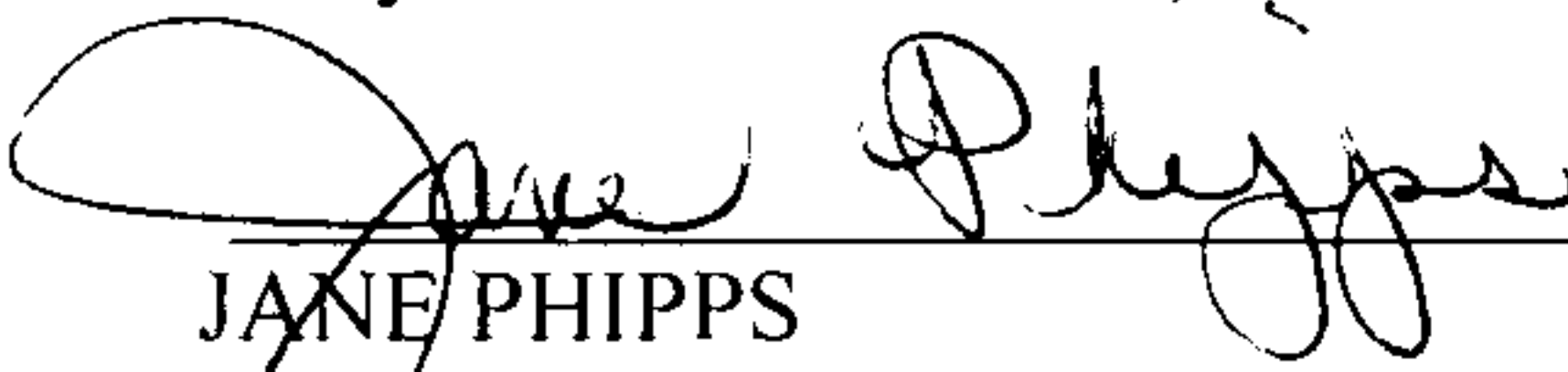
Subject to easements, restrictive covenants, set back lines, limitations, rights of ways as shown by public records and ad valorem taxes as shown of record.
