CARTER**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

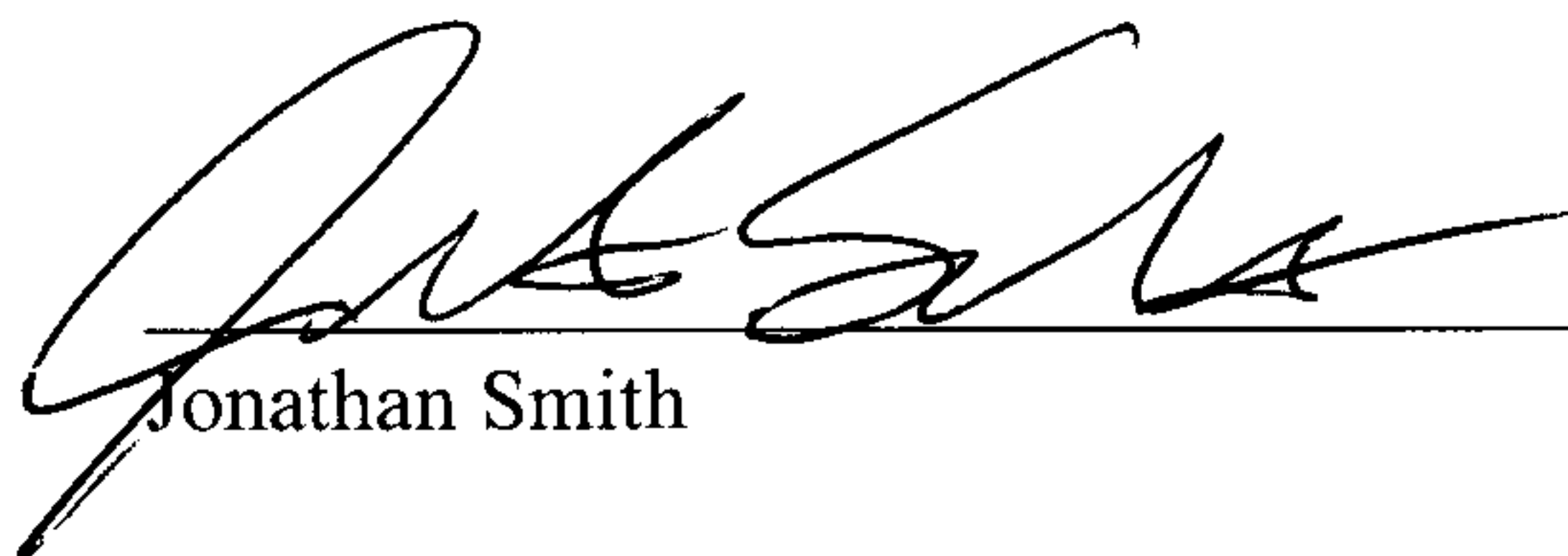
10. Agreement and Indemnification between Alabaster Water Board and Envirobuild, as recorded in Instrument No. 2001-38317.

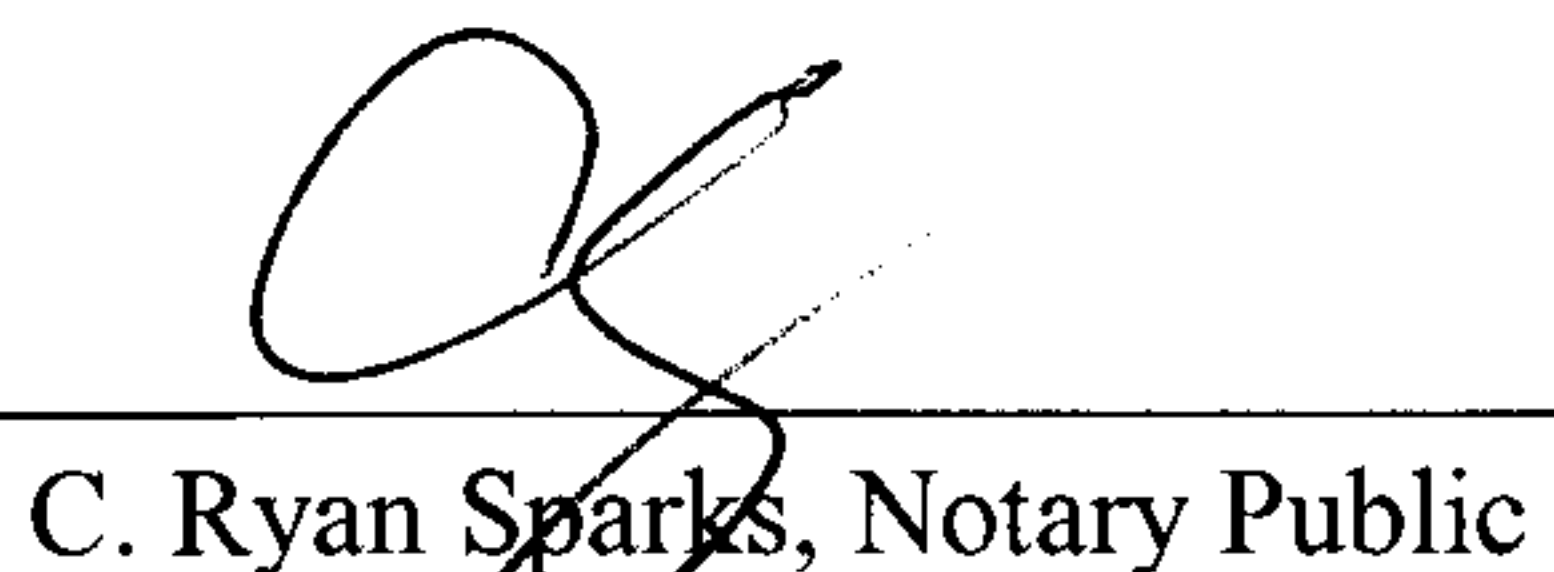

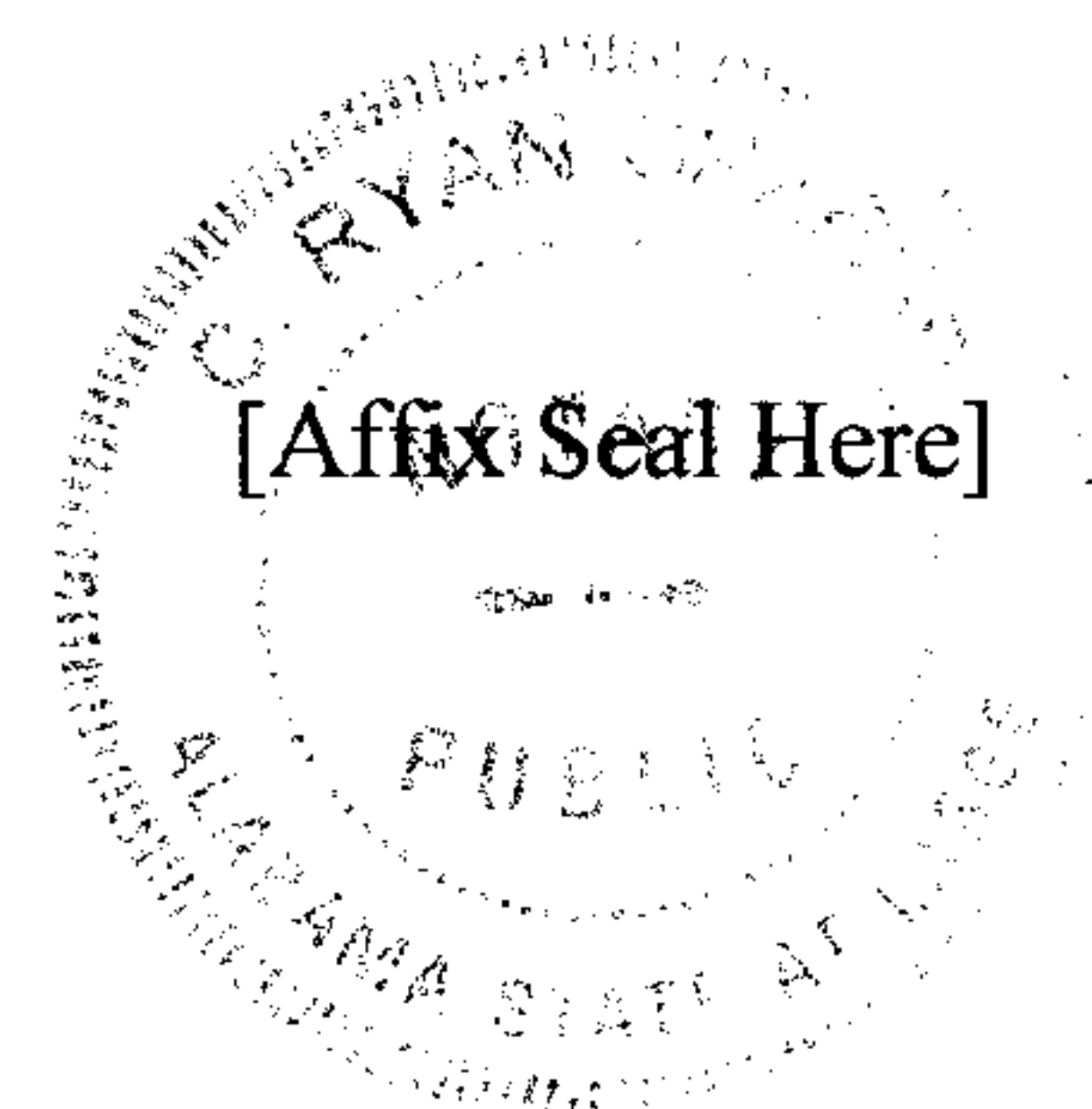
