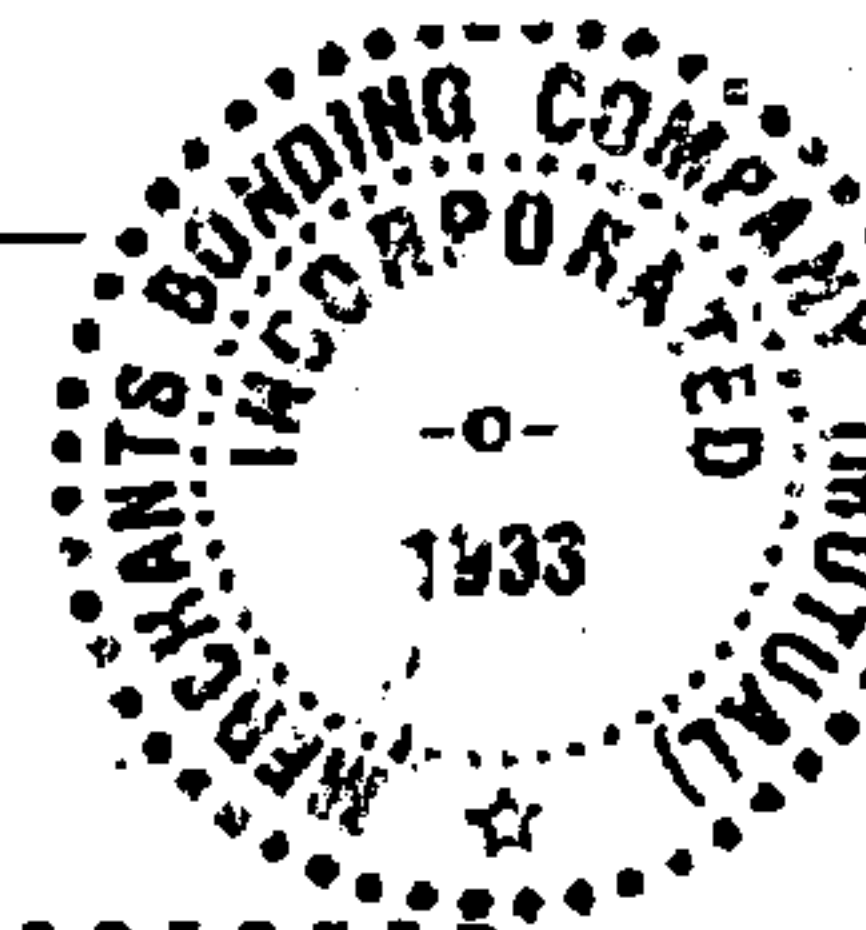

FIVE HUNDRED THOUSAND (\$500,000.00) DOLLARS

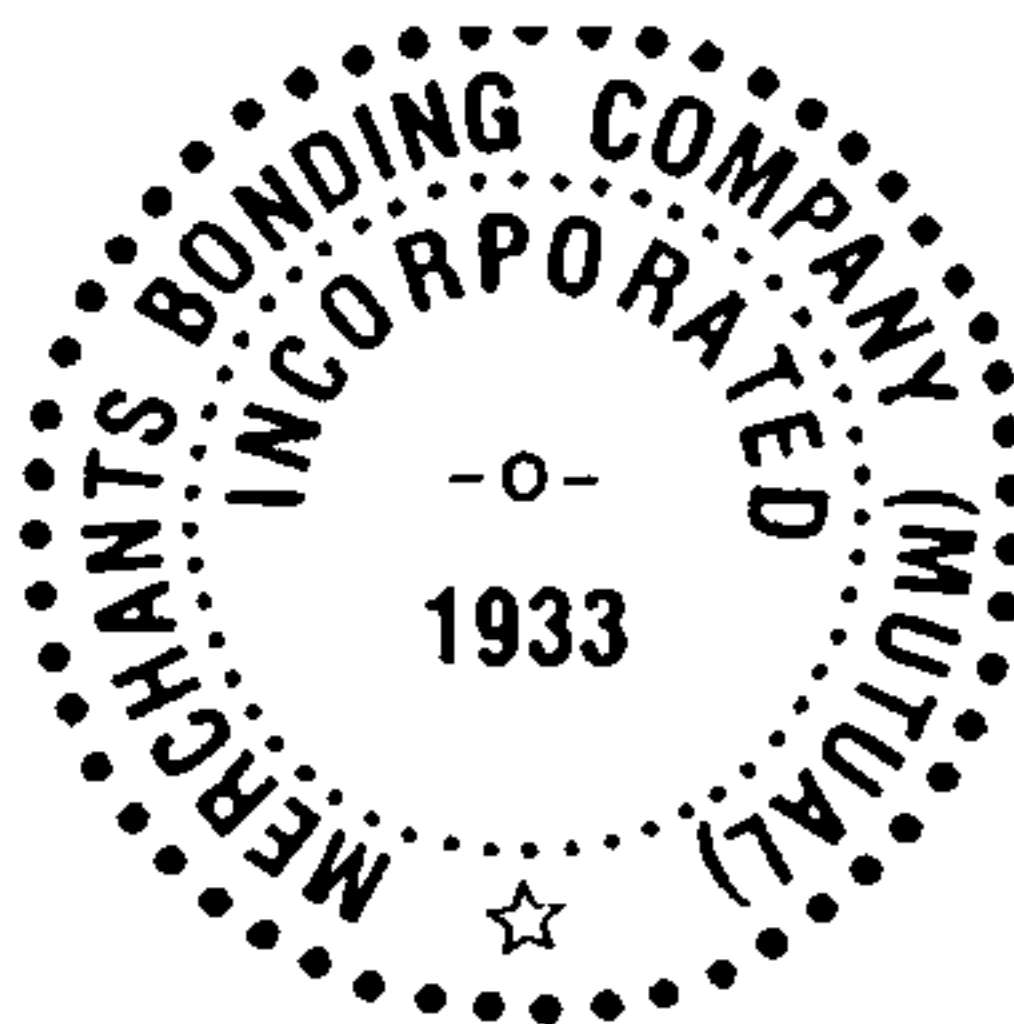

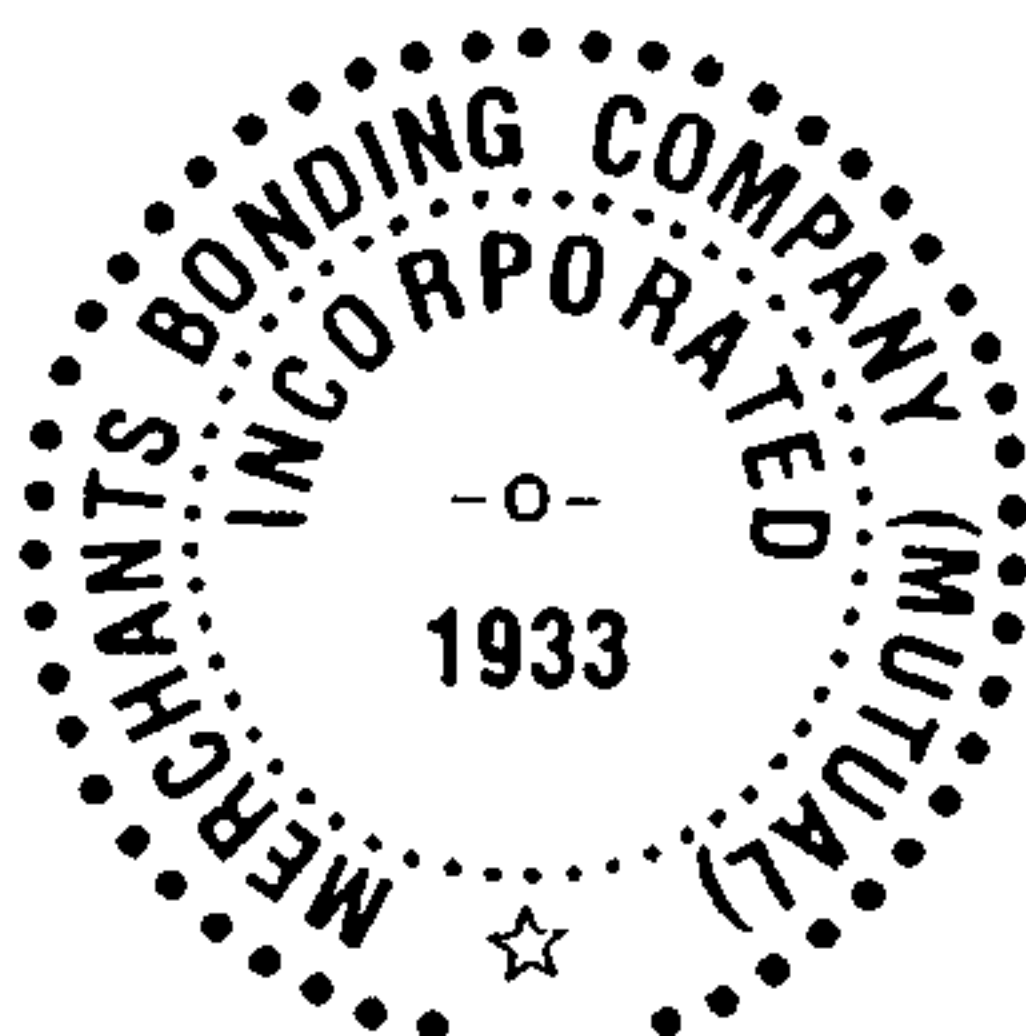
