

FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on January 6, 2012, to-wit: Steven A. Hess, a single man, executed a mortgage to Mortgage Electronic Registration Systems, Inc. solely as nominee for FirstBank, its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on February 7, 2012, in Instrument No. 20120207000045570, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to U.S. Bank National Association, by assignment recorded September 2, 2014 in Instrument No. 20140902000274510, Probate Records of Shelby County, Alabama; and
