- Certain paragraphs of the Final Judgment obligated Raymond Louis Smith, III to pay certain sums to Sheri Giambrone Smith. Said Paragraphs are set forth below:

ALIMONY IN GROSS

That Plaintiff shall pay to Defendant alimony-in-gross in the sum of Seventy-five Thousand Dollars (\$75,000.00) Dollars within sixty (60) days of the date of this Final Judgment of Divorce. A lien is hereby placed upon Plaintiff's real estate for the payment of said \$75,000.00. The real estate subject to this lien is to-wit:

REHABILITATIVE ALIMONY

Further, Plaintiff shall pay to Defendant as rehabilitative alimony the sum of One Thousand Five Hundred Dollars (\$1,500.00) per month for a period of twenty-four (24) consecutive months beginning June 1, 2015, or until the death of either party, Defendant's remarriage, or Defendant's cohabitation as provided by law.

COURT ORDERED PAYMENTS

8. The Court ordered Plaintiff to pay to Defendant the sum of Two Thousand Five Hundred Dollars (\$2,500.00) per month for a period of six (6) months during the pendency of this action. Plaintiff willfully, intentionally and contumaciously failed to pay such sums and is therefore in CIVIL AND CRIMINAL CONTEMPT OF COURT. To purge himself from contempt Plaintiff shall forthwith and without delay pay to Defendant the sum of Fifteen Thousand Dollars (\$15,000.00). Plaintiff is sentenced to five (5) days in jail for his willful failure to pay and the Sheriff of Shelby County, Alabama. is directed to incarcerate Plaintiff for five days; HOWEVER, the Court suspends imposition of such sentence to allow Plaintiff to purge himself as set forth above.

ATTORNEY'S FEES

15. Plaintiff shall pay to Defendant the sum of Thirty-six Thousand Nine Hundred Nine and 15/100 Dollars (\$36,909.15) for and as the reasonable value of her attorney's services in this cause. Said fees shall be remitted by Plaintiff directly to the offices of William Clark, 940 Financial Center, 505 20th Street North, Birmingham, Alabama 35203.
